SUB: WRITTEN COMPLAINT

Sir,

With due respect I, Smt. Mina Darjee@ Meena Darjee, wife of Sri Kaku Darjee presently residing at P.S. Pabitra Nagar, Kalkut, Post Office Champasari, Police station Pradhannagar, Dist Darjeeling would like to inform you that I am the owner of a Plot of land measuring about 1(one) Katha 12 Chhataks as fully described in the schedule below purchased from one Smt Ranjani Singh wife of Sri Upen Singh of Uttar Mallaguri Police station Pradhan Nagar, Dist Darjeeling, by virtue of a Sale Deed, bearing Registration no I-1217 dated 24.02.2016. That after purchasing the same my name has been recorded in the Records of Rights at the Office of the B.L & L.R.O Shiv Mandir at Matigara, vide L.R Khatian no.5529, in respect of L.R Plot 372 of Mouza Kalkut, J.L No.44 under police station Pradhannagar, Dist Darjeeling. That on 15.08.2021 at about 9.30 A.M I received one report that some persons entered into my land and digging the soil and then I reached the spot of my land and found some persons namely (1) Sri Manik Roy, (2) Sri Raju Das, and Monoj with the help of some miscreant are constructing boundary wall upon my land., on query they said that one Gopal Ch. Das sold the land in favor of one person namely Nihal Gupta and as per his instructions they are constructing the same. That whenever I protest the above mentioned persons they along with their associates have started threatening me with dire consequences. Sir, I am a poor lady belongs to Schedule Case community and the below mentioned land is the only property of mine and if they grab the same there will be nothing left for me to survive. That the above persons namely Sri Manik Roy, Sri Raju Das and Monoj in the locality and their associates are dangerous in nature and they prior to this incident had done the same unwanted activities in several times. They also tried to assault me and threatened with dire consequences that if I again come here they do anything.

It is also to be mentioned here that I got the searching of the records of my said land from the B.L & L.R.O Shiv Mandir and got intact that my name has been recorded in the R.O.R as shown in the Plot Information dated 24.08.2021.

Therefore, I am requesting you to kindly look into the matter and restrain the above mentioned persons for their illegal motive and wrongfull gain and save my life.
