- ii) 06 (Six) Pouches of officer's Choice Deluxe Whiskey (each pouch contains 180 ml)


I P.S.I. Chetan Dangal of Pradhan Nagar P.S, SPC would like to lodge a written complainant against the above noted accused person to the effect that today on 27.08.21 at 14:55 hrs myself along with force ASI Ratan Pradhan, CV/223 Swapan Chettri, 646 Baban Das left from P.S for Special raid duty vide PDN P.S GDE NO 1796 27.08.21. During special duty I received an information that one person namely Vishwanath Kumar Mahato has stored huge quantity of illegal liquor in his house situated at Dagapur, Near Baba Loknath Mandir, P.S Pradhan Nagar, Dist-Darjeeling and selling the same from his house for illegal Gain. Accordingly I share the information to you and as per your kind instruction I along with force rush to the spot and hold raid in the house of the above person. On searching his residence recovered above noted articles, and on demand he failed to produce any valid document in respect of the recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 17:55 hrs to 18:45 hrs and after that I arrested him and brought to Pradhan Nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Vishwanath Kumar Mahato (M-22 yrs) S/O Ram Nihara Mahato of Dagapur, Near Baba Loknath Mandir, P.S Pradhan Nagar, Dist-Darjeeling and arrange for its investigation.
