With due respect and humble submission, in producing herewith one accused namely Dilip Singh (M-36 yrs) S/O Lt Mahendra Singh of Cooliepara, Ward No. 01, P.S Pradhan Nagar, Dist-Darjeeling under arrest along with following articles under proper seizure ;

2. 12 (twelve) Bottles of Himalayan Gold Country Spirit 60'UP (each bottle contains 600 ml when packed)

I A.S.I. Ashit Singha of Pradhan Nagar P.S, SPC would like to lodge a written complainant against the above noted accused person to the effect that today on 27.08.21 at 14:55 hrs myself along with force ASI Ratan Pradhan, CV/992 Jagadish Biswas, 242 Rakesh Manger, 645- Pankaj Gupta left from P.S for Special raid duty vide PDN P.S GDE NO 1796 27.08.21. During special duty I received an information that one person namely Dilip Singh has stored huge quantity of illegal liquor in his house situated at Cooliepara, Ward No. 01, P.S Pradhan Nagar, Dist-Darjeeling and selling the same from his house for illegal Gain. Accordingly I share the information to you and as per your kind instruction I along with force rush to the spot and hold raid in the house of the above person. On searching his residence recovered above noted articles, and on demand he failed to produce any valid document in respect of the recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 18:25 hrs to 19:05 hrs and after that I arrested him and brought to Pradhan Nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Dilip Singh (M-36 yrs) S/O Lt Mahendra Singh of Cooliepara, Ward No. 01, P.S Pradhan Nagar, Dist-Darjeeling and arrange for its investigation.
