Sir,

Most respectfully, I, SI. Binup Mahato of Pradhan Nagar PS /SPC would like to inform you that today i.e. on 27.08.21 in course of Simultaneous drive vide Pradhan Nagar PS GDE No. 1796 Dt. 27.08.21 and Off. No. 2682 (SS)/SB/SPC Dt. 24.08.21 and Police West Bengal Off. No. 357/CORD CELL Dt. 21.08.21 myself along with ASI Debasish Das, CV/646 Baban Das, CV/645 Pankaj Gupta, CV/223 Swapan chettri and CV/242 Rakesh Mangar was performing raid against rowdies and illegal activities under Pradhan Nagar PS area. At about 19.00 hrs while we reached at Gobinda Nagar main road under Pradhan Nagar PS/SPC, one person namely Bibek Roy, S/O. Shibalal Roy of Champarai, Pradhan Nagar was found driving his motorcycle in an excessive speed and roughly showing fear to the pedestrians. We gave signal to stop him, but the person fled away. After a while the bike rider again returned back and started abusing us by using slang languages and started obstructing us from lawful duty. Finding no other alternative we detained him at spot but he started kicking and punching us and shouting and gathered local people. Then a group of local people assembled there and knowingly our identity they started abusing us physically being instigated by said Bibek Roy. Mine while said Bibek Roy managed to flee away covering the public gathering. As a result of assault my accompanying officer ASI Debasish Das and CV/128 Ajoy Kumar Sahani received grievous injuries and immediately shifted to Siliguri District Hospital where medical officer advised ASI Debashis Das for admission as he got fracture injury on his left thumb. CV/128 Ajoy Kumar Sahani treated medically for his injuries. The agitated mob also threatened police with dire consequences. However, re-enforcement was done and managed to apprehend 4(four) persons namely (1) Kush Kumar Prasad(27) S/O Prabhunath Prasad of Champasari Circuit House, Singarakata, Ganesh Ghosh Colony, Ps. Pradhan Nagar, Dist-Darjeeling, (2) Bishnu Mohanta(26) S/O Bipul Mahanto, Krishna Nagar, Debidanga, Ps Pradhan Nagar, Dist-Darjeeling, (3) Rakesh Jaiswal(35) S/O Gopal Jaiswal of Gurung Busty, Road no.1, Ps Pradhan Nagar, Dist-Darjeeling, (4) Sandip Kumar Gupta(20) S/O Kashi Nath Gupta of vill- Barua, PO. Hanumangach, Ps Sakora, Dist-Balia, Uttar Pradesh A/P of Debidanga Bazar, Ps, Pradhan Nagar, Dist-Darjeeling and other 15/16 miscreants managed to flee away.

Under these circumstances, I pray before your good self to take legal action against said (1) Bibek Roy, (2) Kush Kumar Prasad(27), (3) Bishnu Mohanta(26), (4) Rakesh Jaiswal(35) (5) Sandip Kumar Gupta(20) and others 15/16 miscreants may kindly be taken for using criminal force to Police personnel in uniform, obstructing public servant and causing hurt to deter public servant while discharging his government duty.
