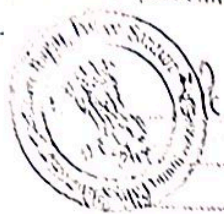

FIR against Krishna Sahani, Dipak Choudhury, Sagar Harijan, Manoj Harijan, Renu Harijan and others

Reverend Sir,

With adorable submission I Jogender Das S/o Late Bangali Das resident of Dharam Nagar Ward No-1, PO- Pradhan Nagar, PS- Pradhan Nagar Siliguri Dist- Darjeeling would like to access my complain before your core of magnanimity that on 22-08-2021 at about 10:30PM Krishna Sahani of Rajendra Nagar Sahani Patti ward no-1, Dipak Choudhury s/o Hareram Choudhury of Rajendra Nagar and others suddenly came to Dharam Nagar where my Son Munna Das was playing LUDO game, before he could understand anything they all started using filthy languages and attacked my son bitterly, in this incident my son injured critically and admitted to Siliguri District Hospital.

That Sir, on 25-08-2021 at about 7:00 PM Krishan Sahani, Dipak Choudhury, Manoj Harijan and his son and wife Mr Sagar Harijan, Renu Harijan and others came to our area and started using filthy languages and threatening to us that if we do not withdraw the complaint lodged to Pradhan Nagar Police Station and did not compromise then they all will beat us. Once again we couldn't understand anything and they all started beating us and ran away, after a while a Mr Krishna Sahani, Dipak Choudhury, Manoj Harijan and his son and wife Mr.Sagar Harijan, Renu Harijan and others unknown about 100-150 nos goon group where each and everyone has different weapons like Sword, Iron Rod, Steel pipe Lathi, arm Punch etc and started us beating bitterly where my another son Mr Kanchan Das 23 years old attacked by Krishna Sahani with a Sword critically injured on head and our other family members and locals injured. We thank to the Police officer SI Mr. Rabindra Nath Sarkar who came in a Police van and laid my son to Siliguri District Hospital without losing time. Mr Rabindra Nath Sarkar also seized the sword.

That Sir, I belong to a very poor family and the family income is so pathetic, on 26-07-2021 I was informed by District Hospital that the condition of my son is very serious and transferred to NBMC & Hospital at 3:00 PM on 26-08-2021, The Medical Doctor said that they have no any Neurologist at that time and the Condition of the patients is getting very serious where he must be referred to Kolkata for better treatment of may be admitted to any Nursing Home. Somehow, I admitted my son Kanchan Das to Sanjeevani Neuro & Multi Speciality Hospital under Dr Amitav Mishra with the help of local's financial supports where his brain surgery done at 01:30 AM 27-08-2021. Now he is surviving under death and alive in a very serious condition.

That Sir, our family are now under scared situation, as above-mentioned goons threatened us that they will kill us. If anything happen to our family, they all will be responsible in future.

Therefore I implore my urge before you to kindly look after the afore-said matter and do the necessary legal action against them at the earliest by proving your mercy. If so then I will be highly obliged to you forever.
