**Sub: F.I.R. against (i) Shambhu Nath Saha, S/o- Lt. Subal Ch: Saha (ii) Choton Ghosh, S/o- Lt. Sadhan Ghosh the present user and (iii) Sudhanya Saha, S/o- Lt. Subal Ch. Saha for unauthorised use of electricity by using Domestic Meter for Commercial purpose.**

Dear Sir,

I, Kausick Kumar Das, AE & Station Manager, Subhaspally CCC do hereby lodge this written complaint against Shambhu Nath Saha, S/o- Lt. Subal Chandra Saha at Ashigarh More, EM Bye Pass, P. O- Ghogomali, P.S. - Bhakti Nagar, Dist.: Jalpaiguri, (M) 9733216950 for unauthorised usage of Domestic connection having Con. ID : 401728947 Meter no.: OB4549791 for commercial purpose. The present user Choton Ghosh S/o- Lt. Sadhan Ghosh, running a Marbel & Tiles shop styled as Priyanka Enterprise use this domestic line for his shop of approx. 1 KW(approx.) light & fan load illegally and unauthorisedly and thereby liable under Section 135(i)(e) of Electricity Act.

Today (26.08.2021) at 15.10 hrs. I, along with Sri Malay Kumar Goswami, DE (S&I.P), Darjeeling Regional Office and other supporting staff of Mobile Van had been to the above address for inspection. During inspection it is found that the said tenant Choton Ghosh is consuming the electricity energy approx. present demand 1KW(approx.) by using Domestic Connection for Commercial purpose unauthorisedly and illegally. The present reading of the said meter is 1998 units.

Another 1 no. energy meter having sl. No. OB4549772, Bentec make in the name of Sudhanya Saha, S/o- Subal Ch. Saha [Con. ID: 401728946] found at the same premise.

Accordingly, I issued a notice and served a copy to the consumer. As the unauthorized use of electricity detected, the service connection has been disconnected with removal of said energy meter, also prepare the Inspection report followed by the seizure of both energy meters [(i)OB4549791 Bentec Make & (ii)OB4549772, Bentec Make ] and supplied the copies of it to the representative of the premises owner.

- (i) 2 ft. Flexible wires as sample.
- (ii) Both energy meters bearing nos. (i)OB4549791 Bentec Make & (ii)OB4549772, Bentec Make, IPII (5-30)A.

Therefore, Shambhu Nath Saha has committed an offence under Section 135(i)(e) and (i)Choton Ghosh & (ii) Sudhanya Saha has committed an offence under Section 150 of Electricity Act.

So, It is requested that a case may kindly be initiated against those and arranged for its investigation.
