In producing herewith one accused person namely Madan Limbu (52) S/O Iman Limbu Of Chhotafabri PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

- (1) 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/- (Total- 15 Liter & Amount Rs 1500/-).
- (2) 06 (Six) bottle of McDowell's No-1 CELEBRATION MATURED XXX RUM each bottle containing 180 ML, MRP Rs. 153/- (Total - 01.80 Liter Rs 918/-)

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Madan Limbu (52) S/O Iman Limbu Of Chhotafabri PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 18 .08.2021 evening as per order of O/C Ashighar OP I along with ASI Sumit Baran Nath C/ 877 Munna Ahmed , C/134 Ginen Basunata and CV/307 Fulkumar Barman , all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 715 Dt 28.08.2021 in course of which I received information from my source that one Madan Limbu stored a huge numbers of bottles of liquor inside his house at Chhotafabri and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Chhotafabri area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinagar Dist. Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjan Nagar W/no.36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Chhotafabri PS Bhaktinagar Dist. Jalpaiguri area as indicated by my source I held raid at the house Madan Limbu at Chhotafabri .But seeing us the above noted accused person tried to flee away from the spot, but we man aged to apprehend him . I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 16.55 hrs and 17.10 hrs on 28.08.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Madan Limbu (52) S/O Iman Limbu Of Chhotafabri PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
