Respected Sir,

I Sri Jagmohan Poddar, S/o Sri Rohit Poddar, resident of Himalaya apartment, Shaktigargh road No 2, Millanpally, Siliguri, the constituted attorney of Sri Shibu Munda S/O Late Ashilal Munda, resident of Nischintapur Tea Estate, Matigara, P.O & P.S. Matigara, District. Darjeeling, beg to inform you that on being dissatisfied with the inaction by the Project Officer Cum District Welfare Officer I preferred an application before the West Bengal Land Reforms and Tenancy Tribunal being O.A No. 613 of 2021 against the Narendra Chandra Garg and Others and after hearing the Id. Tribunal was pleased to pass an interim order on 15/03/2021 wherein the Id. Tribunal restrain the said Narendra Chandra Garg from any further work on the suit land i.e. the land measuring 1.47 acre in L.R Plot No. 325, L.R Khatian No. 20, Mouza- Baniakhari, J.L No. 55, under the P.S. Matigara, Dist. Darjeeling. otherwise the injury is likely to be caused to me and therefore the Id. Tribunal issue the interim order upon the Narendra Chandra Garg not to proceed in any work on the suit land (photo copy of the order is enclosed herewith).

That it is further mention herein that on 4/11/2020 I filed a written complain before your authority as the said Narendra Chandra Garg was carrying the construction work on the suit land (copy of the said written complain is annexed herewith).

It is pertinent to mention herein that before filing O.A application being No- 613 of 2021 before the L.R.T.T at Kolkata, I preferred a Writ petition before the Hon'ble High Court at Calcutta Circuit Bench at Jalpaiguri being WPA No- 9976 of 2020 corresponding to WPA No- 75 of 2021. That at the time of hearing of the said Writ petition the Hon'ble Justice Mausumi Bhattacharjee issued a verbal direction on

22/01/2021 against the Narendra Chandra Garg that he was not allowed to proceed with any construction work till the next hearing. Thereafter the said Writ petition was again taken up for hearing on 25/01/2021 wherein I alleged that inspite of the verbal order the said Narendra Chandra Garg was carrying the construction work on the site and to that effect I submitted some photographs dated 23/01/2021 and on hearing of the said allegation the said Narendra Chandra Garg was directed to file an affidavit before the Hon'ble High Court and accordingly the said Narendra Chandra Garg was filed an affidavit before the Hon'ble High Court on the self same day stating that there was no construction work was carried out since 23/01/2021.

I further submitted that just after passing the order on 15/03/2021 by the Hon'ble Tribunal, I have taken some photographs of the site and thereafter I filed a written complain before your authority on 01/04/2021 stating that I have a serious apprehension that the said Narendra Chandra Garg will not obey and regards the order passed by the Hon'ble Tribunal in connection with the O.A No- 613 of 2021. That recently I heard from the locality where the land in question is situated that some laborers and workers of Narendra Chandra Garg are continuing with the construction work on the site and therefore I rushed to the spot and taken some photographs on 19.08.2021 wherefrom it can be gathered that said Narendra Chandra garg and his men and agents carrying out the construction on the site even after order passed by the Hon'ble Tribunal in connection of the O.A No- 613 of 2021 (photocopy of the written complain dated 01/04/2021 is annexed herewith).

Therefore it is requested to you kindly take the serious step against the said Narendra Chandra Garg and his men and agents for violation of the order passed by the Hon'ble Tribunal in connection with the O.A No- 613 of 2021.
