I, SI Kankan Paul of Bagdogra Ps., Siliguri Police Commissionerate do here by lodged this complaint against 1. Thakur Sha @ Veer Sha 21yrs s/o Late Rameswar Sha of Bagdogra Airport market More Ps; Bagdogra Dist. Darjeeling West Bengal to the effect that on 29.08.21 at 23.05 hrs received a secret source information that one person having possession huge quantity of brown sugar are standing with a two wheeler motor cycle Pulsar bearing RC No WB74BB/3109 black color at Gosaipur in front of Uttara for clandestinely disposal of the same illegally at and around Shibmandir Matigara and Siliguri area. The matter was diarized vide Bagdogra Ps. GDE No 1866 at- 29.08.21. Accordingly, I informed the matter to O.C, Bagdogra PS, and as per his instruction myself along with ASI Jakirul Islam, ASI Dhirendra Nath Mandal, C/410 Montosh Singh, VP- 02 Pradip Roy, CV/389 Janak Singha and CV, 375 Jogesh Singha left for the spot at 23.10 hrs to verify the veracity of the information vide corresponding Bagdogra Ps G.D.E. No. 1867 dtd 29.08.2021 and Bagdogra Ps M.C.C No1631/21 Dt 29.08.21. At the time of departure from Police Station, I bring spring weighing clock, small balance with stone, envelope, white paper, sealing wax, gum, seal etc. On way to spot at Gosaipur in front of Uttara meanwhile. called two independent witnesses namely 1. Sri Uttam Karmakar 31yrs s/o LATE Budhan Karmakar 2. Sri Subhankar Ghosh 22yrs s/o Bachhu Ghosh Ps Bagdogra Dist. Darjeeling both of Mulaijote Nutanpara Ps Bagdogra Dist. Darjeeling informed them about the information in hand and requested them to accompany us to witness the search and seizure if necessary. At about 23.35 hrs on arrival there by govt. vehicle parked the vehicle in a considerable distance as identified by the source we surrounded the place and around 23.50 hrs we found that one person was standing at Gosaipur in front of Uttara with a two wheeler motor cycle Pulsar bearing RC No WB74BB/3109 black color along with some youths on the spot seeing the police party the youths run to fiee away somehow we apprehended one Thakur Sha @ Veer Sha with one two wheeler motor cycle Pulsar bearing RC No WB74BB/3109. On being asked he disclosed his identity as noted above. After disclosing our identity. I asked him whether he wanted to be searched in presence of Executive Magistrate or any Gazetted Officer and he agreed to search by any one. I served him option notice u/s 50 NDPS Act accordance with provisions of law in this regard in writing and he also gave his approval of being searched by any one in writing in the notice serve to him. Accordingly, I informed the matter to O.C. Bagdogra Ps and he informed me over mobile phone to send one requisition to Sn Pasang Topgay Bhutia ,ACP, Traffic (West), SPC Special Executive Magistrate of SPC for the day. Accordingly, I informed to Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC as Special Executive Magistrate of SPC for the day and request to came to the spot. At about 00.55 hrs. Sn. Pasang Topgay Bhutia ACP, Traffic (West), SPC, Special Executive Magistrate of SPC for the day and O.C. Bagoogra Ps. arrived at the spot. I disclosed the identity of Sn Pasang Topgay Bhutia ,ACP, Traffic (West), SPC. Special Executive Magistrate of SPC for the day to the accused persons and also witnesses. I also offered the independent witnesses and the accused person to search our Police Party as per provision of law. But they refused to search the police party. Under supervision of Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC, Special Executive Magistrate of SPC for the day and in presence of independent witnesses. I conducted searched and recovered One zipper transparent thin plastic packet in contents, believe to be brown sugar which

kept concealed on the right pocket (full pant) of Thakur Sha @ Veer Sha on weighing by the weighing instrument and found total 35 gram believe to be brown sugar and Marked as Exhibit -"A" and 05 Grams said to brown sugar taken as sample from the Exhibit -"A" in one separate thin plastic packet and marked as "A-1" on search the two wheeler motor cycle black Pulsar Dominer bearing RC No WB74BB/3109 and as per leading statement of the Prakash Sha @ Veer Sha down side of sit recovered one zipper transparent thin plastic packet in contents believe to be brown sugar on weighing by the weighing instrument and found total 35 gram and Marked as Exhibit - "B" and 05 Grams said to be brown sugar taken as sample from the Exhibit -"B" in one separate thin plastic packet and marked as "B-1" believe to be brown sugar On demand in presence of the Special Executive Magistrate of SPC for the day Sri Pasang Topgay Bhutia. ACP, Traffic (West), SPC, Thakur Sha @ Veer Sha failed to produce any valid document in support of

possessing of the contraband articles believed to be Brown Sugar

I accordingly, labeled and sealed all the recovered article in presence of Sn Pasang Topgay Shutia . ACP, Traffic (West), SPC, Special Executive Magistrate of SPC for the day and independent witnesses and accused person. Then I seized the above noted articles under proper seizure list and label duly signed by the above noted witnesses and the Special Executive Magistrate of SPC for the day Sri Pasang Topgay Brufia ACP, Traffic (West), SPC and acknowledged by the accused persons. The seizure was made between \$1.00 hrs to 02.15 hrs. On further interrogation the apprehend person Thakur Sha @ Veer Sha confessed in presence of Special Executive Magistrate Sri Pasang Topgay Bhutia (ACP, Traffic (West)) SPC and other witnesses that he procured the said brown sugar procured clandestinely from Islampur area to sell the same from his village area to his designated customers purpose of selling in order to earn huge money quickly during the time of pandemic situation COVID-19. Then, I arrested the accused person u's- 41 Cr.P.C after observing all formalities of arrest as well as disclosing the cause of arrest and issued Memo of Arrest. The copy of seizure list and Memo of Arrest has been supplied to him under proper receipt as the accused person violated the terms and condition of NDPS Act

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused persons namely 1. Thakur Sha @ Veer Sha 21yrs slo Late Rameswar Sha of Bagdogra Airport market More Ps. Bagdogra Dist. Darjeeting West Bengal and arrange for its investigation. Enclosure
