In producing herewith one accd. (1) Bikash Soren (22) s/o Ashik Soren of Bedgara, PO Salugara, Dabgram I, PS-Bhaktinagar, Dist-Jalpaiguri and (2) Rahul Hembram (19) s/o Suresh Hembram of Singhijhora, Dabgram, I, P.O Salugara, P.S Bhaktinagar, Dist. Jalpaiguri along with seized tractor bearing registration no WB 71 B 4642 loaded with sand.

I SI Harish Ch. Basak of Bhaktinagar PS /SPC do hereby lodge this written complaint against driver of truck bearing no WB 71 B 4642 Bikash Soren (22) s/o Ashik Soren of Bedgara, PO Salugara, Dabgram I, PS-Bhaktinagar, Dist-Jalpaiguri and Rahul Hembram (19) s/o Suresh Hembram of Singhijhora, Dabgram, I, P.O Salugara, P.S Bhaktinagar, Dist. Jalpaiguri, that on 31.08.2021 I along with force had been performing K-37 Van duty vide GDE No. 1675 Dated 31.08.2021 & MCC No. 504/2021 Dated 31.08.2021. While performing above noted duty received information from my reliable source that a truck bearing registration no WB 71 B 4642 loaded with Sand collected from the river bed of Mahananda and proceeding towards Eastern By Pass Road. After receiving information, I shared the information with I.C. BKN PS and as per his direction, I along with force chased the truck and detained at Pradhan Para under Bhaktinagar PS and asked him to produced the valid documents in respect of the loaded sand river bed materials but the driver of the said truck failed to produced any valid documents in respect of the loaded sand and the driver of the vehicle also stated that he had loaded the sand illegally under the order of owner for the vehicle Lakhan Barman s/o Nripendra Nath Barman of Pradhanpara, P.O Salugara, PS Bhaktinagar, Dist Jalpaiguri for his personnel gain. Hence, I seized the above noted truck along with loaded ^{Sand} stone chips under proper seizure list duly signed by available witnesses and arrested the driver of the truck observing all legal formalities u/s 41 Cr.P.C.

Hence under the above circumstances, I pray before your kind end that a specific case under appropriate penal section of Law may kindly be initiated against the driver of the above noted vehicle (1) Bikash Soren (22) s/o Ashik Soren of Bedgara, PO Salugara, Dabgram I, PS-Bhaktinagar, Dist-Jalpaiguri and (2) Rahul Hembram (19) s/o Suresh Hembram of Singhijhora, Dabgram, I, P.O Salugara, P.S Bhaktinagar, Dist. Jalpaiguri and the owner of vehicle Lakhan Barman s/o Nripendra Nath of Pradhanpara, P.O Salugara, PS Bhaktinagar, Dist Jalpaiguri.
