Again, on pretext of the same reason they took Rs. 1,00,000 on 06/11/2020 more as they had booking of marriage of Mayfair, Siliguri. During their stay they convinced me that they are going to purchase 13 and half (13.5) Kathas of land near Don Bosco School after selling that flat at Guwahati for Rs. 65,00,000 @ 9,00,000 per Kathas. They have Induced me by telling me that they will share profits from their said business in land sale and cheated me and duped me of Rs. 5,00,000 plus Rs. 1,50,000 on account of rent, electricity bills, etc.

So, considering the facts and circumstances mentioned above you are requested to look into this matter and take proper action against these tricksters and protect myself, my property and several other people.
