Sir,

In producing herewith arrested accused person namely Sushanta Sarkar (40) S/O Sushil Sarkar of Hatiadanga, near Kali Mandir, PS- Bhaktinagar, Dist- Jalpaiguri along with seized articles vize- i) 10 (Ten) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 10 x Rs 100/- =RS.100/-) and ii) 11 (Eleven) sealed bottles of Himalayan Gold 60 up country spirit containing 300 ml each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 11 x Rs 50/- =RS.550/-), iii) 05 (Five sealed bottles of Officer's Choice Blue whisky containing 180 ml each amounting of Rs. 174x05 = Rs. 870/- and iv) 04 (four) sealed bottles of Imperial Blue whiskey containing 180 ml each (amounting of Rs. 174x04 = Rs. 696/-) as per seizure list.

I, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person Sushanta Sarkar (40) S/O Sushil Sarkar of Hatiadanga, near Kali Mandir, PS- Bhaktinagar, Dist- Jalpaiguri to the effect that on 14.08.21 at 19.35 hrs acting on secret information, I received a source information that the above noted person was busy to sale Id liquor illegally in the open area situated at Bagrakot Bus stand under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 920 dated 14.08.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with PSI Rajiv Subba, CV/283 Prosenjit Dey & CV/622 Ramanath Barman left for Bagrakot Bus Stand under Siliguri PS to verify the veracity of the information vide Siliguri PS GDE No. 921 dated 14.08.21. On reaching at 19.55 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the

spot but we managed to apprehend the above noted person and on interrogation, the above noted person disclosed his identity as noted above. On searching - i) 10 (Ten) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 10 x Rs 100/- =RS.100/-) and ii) 11 (Eleven) sealed bottles of Himalayan Gold 60 up country spirit containing 300 ml each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 11 x Rs 50/- =RS.550/-), iii) 05 (Five) sealed bottles of Officer's Choice Blue whisky containing 180 ml each amounting of Rs. 174x05 = Rs. 870/- and iv) 04 (four) sealed bottles of Imperial Blue whiskey containing 180 ml each (amounting of Rs. 174x04 = Rs. 696/-) which was kept concealed in the bush situated at Bagrakot Bus Stand. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 20.05 hrs to 20.50 hrs. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. As such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person Sushanta Sarkar (40) S/O Sushil Sarkar of Hatiadanga, near Kali Mandir, PS- Bhaktinagar, Dist- Jalpaiguri along with seized articles under proper section of law and arrange for its investigate.
