Sir,

I, Mayank Jindal S/o Anil Kumar Jindal resident of Sevoke road, Siliguri, would like to bring to your attention the following matter.

1. That a person named Rohit Singh phone no. 79085-58512 resident of Shivmandir, Bagdogra along with is unknown gunda forcefully entered my office at around 1:30 pm. One of them accompanied him to my chamber having some knife as well.
2. For matters unknown he demanded a sum of money saying 'you had to pay us to work and live in this city'.
3. Upon my refusal and politely asking him to leave my premises he started abusing me and told me that he would kill me if I step out of the house as he is a big goon along with his friends.
4. That he also told me if I don't pay the particular sum of money he would kill my family on the street of siliguri. In the meanwhile he also picked up a chair and hurled against me hurting me physically in the process.
5. That if my staffs namely Mr. Debasis Roy and Jeevan Kr. Sinha would not have been present he would have hurt me grievously. Both are also are witness in the incident.
6. That I am attaching CCTV footage of this attack on me along with his aggressive start of dealing.
7. That I implore you to look into the matter and provide me protection against such unsocial elements I deeply think my life is threatened by him.

I request for swift and immediate action to catch the culprit.
