Sir,

In producing herewith two accused persons namely (1) Sankar Sikdar ( 22 years ) S/O Sri Suniti Sikdar of 2 no. Maghpala PS Sitalkuchi Dist Cooch Bihar and (2) Jayanta Biswas ( 25 years ) , S/O Sri Ratan Biswas of do under custody and the following properties under seizure ----

- (1) 01 (One ) packet said to be Ganja wrapped with brown coloured Cello tap weight 5(Five )Kgs which was kept in a one black coloured trekking bag marked as exhibit - "A"  
(2) One red coloured Apache RTR 160 Motor cycle bearing registration no. WB/86B- 1313 with key. Marked as exhibit - "B"

Seized the above noted articles from the joint possession of Sankar Sikdar and Jayanta Biswas .

I, S. I. Pradip Kr Singha of Ashighar OP P.S. Bhaktinager SPC, do here by lodge this complaint to the effect that on 02.09.2021 at 14:45 hrs. received a secret source information that two notorious drug peddlers of Cooch Bihar namely (1) Sankar Sikdar and (2) Jayanta Biswas are now standing at Ashighar More, Near Power house Eastern Bypass riding on a Motor Cycle with one bag of Ganja in their possession in order for its clandestine disposal at Ashighar More area and they can be caught red handed, if they apprehended immediately. Accordingly, I diarised the matter vide Ashighar OP G.D.E. No. 43 dated -02.09.2021 and informed the matter to O/C, Ashighar OP and as per his kind instruction myself along with ASI Krishna Ch Singha, ASI Prahlad Singha and C/877 Munna Ahmed and CV/ 1016 Anurit Roy all are of Ashighar OP left for Ashighar More, Near Power House Eastern Bypass at 14.55 hrs. to verify the veracity of the information vide Ashighar OP G. D. E. No. - 44 Dated - 02.09.2021. On way to Ashighar More, Near Power House Eastern Bypass, I called two independent witnesses namely [1] Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinager Dist. Jalpaiguri and [2] Sujit Roy (28) S/O Sanjay Roy of Naresh More PO Ghugumali PS Bhaktinager Dist Jalpaiguri and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 15.05 hrs. myself along with my accompanying party arrived at Ashighar More, Near Power House Eastern Bypass and at contacted with my source. At 15.15 hrs. as identified by my source myself along with my accompanying party surrounded the above noted accused persons those were standing riding on a red coloured Motor Cycle and a black coloured trekking bag kept in between them and waiting for someone. On being asked they disclosed their identity as noted above. On being further asked they stated that the content inside the black coloured trekking bag in their possession is Ganja. After disclosing our identity I asked them whether they have any objection to be searched in presence of any Executive Magistrate or Gazetted officer and they agreed to be searched in presence of any Gazetted Officer. I served them a notice in accordance with the provisions of law in this regard. Then at 15.25 hrs. of 02.09.2021 I apprised Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC and requested him to remain present at the spot as Gazetted Officer. At 15.45 hrs. Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC arrived at the spot. I disclosed the identity of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, and SPC to the accused persons as Gazetted Officer. Under supervision of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC and the above noted witnesses the aforesaid accused persons and the above noted black coloured trekking bag & motor Cycle were searched keeping strict regard of their decency and recovered Ganja contained one packet wrapped with brown coloured cello tap, inside the black coloured trekking bag, which the above noted accused persons were carrying themselves by the above motor Cycle. They further confessed in presence of Gazetted Officer and other witnesses that they procured the Ganja from Assam clandestinely for the purpose of its selling with a

view to earn huge money quickly. On interrogation they disclosed that they had been dealing in such business for last few years importing it from Assam and selling the same at Ashighar and its adjacent areas. On being asked they failed to produce any documents or license in support of their possession of Ganja. Then as per direction of Shri Amaresh Singh, Inspector Incharge Bhaktinagar Police Station, SPC I weighed the Ganja with weighing instrument and found that weight of 01 (one) packet wrapped with brown coloured Cello tap 5 (Five) Kgs which was kept in a black coloured trekking bag recovered from the joint possession of above noted accused persons. Then, I packed, labeled and sealed the bag in presence of witnesses, and seized the above noted recovered Ganja and Motor Cycle bearing registration no. WB86/B 1313 by which they carrying the said Ganja as Alamat under proper seizure list under the supervision Shri Amaresh Singh, Inspector Incharge Bhaktinagar Police Station, SPC duly signed by the local witnesses and the accused persons. The seizure was made in between 16.15 hrs and 16.45 hrs. Then, I arrested the above noted accused persons after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest duly signed by the accused persons and witnesses. The copy of seizure list and memo of arrest have been supplied to the above noted accused persons under receipt. Thus, the accused persons violated the terms and conditions of N. D. P. S. Act. for possessing Ganja without any legal authority.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (1) Sankar Sikdar ( 22 years ) S/O Sri Suniti Sikdar of 2 no. Maghpara PS Sitalkuchi Dist Cooh Bihar and (2) Jayanta Biswas ( 25 years ) S/O Sri Ratan Biswas of do and arrange for its investigation.
