Sir,

In producing herewith one accused persons namely Bapi Singh (36) S/O Lt. Gopal Singh of Daribhit Ps Islampur, Dist-Uttar Dinajpur under arrest along with following seized articles:-

- (1) 26,860 kgs (twenty six kgs eight hundred sixty gms)of said to be ganja inside a white big size Gunny bag which was being carried by accused Bapi Singh marked as exhibit "A".(Weighing with bag)
- (2) 100 grams of said to be ganja extracted from exhibit A for examination and marked as Exhibit A-1.

I SI- Haren Kumar Mohanta presently posted at Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted accused person who had been arrested for contravening the norms of NDPS Act to the effect that today on 05.08.21 at 22:10 hrs myself received a secret source information that one person is waiting at Bihar Bus stand near Siliguri Tenzing Norgay Bus Terminus with a huge quantity of Ganja in a big size of Gunny bag in his possession with a view to transport and sale the same in Patna, Bihar procured from Assam, he could be caught red handed, if apprehended immediately. Wasting no time I diarized the information to Pradhan Nagar PS GDE NO- 338 Dated 05.08.21 and consequently informed the tip off to you for kind instruction. Subsequently on being directed, myself along with SI.Binup Mahato, PSI. KaPSI.Chetan Dongal, ASI. Rtan Chetri CV/131 Ranjan Sharma, CV/223 Swapan chettri and CV/242 Rakesh Mangar left PS along with investigating kits i.e, the weighing articles, envelope, gum, seal etc from Pradhan Nagar PS at 22:20 hrs for perusing the information by Govt. Vehicle bearing regd. no. WB 74 AC 9851. This refers to Pradhan Nagar PS GDE No- 340 Dated 05.08.21 and MCC No. 1458 DT. 05.08.21. under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. While going to Bihar Bus Stand near Siliguri Tenzing Norgay Bus Terminus, we stopped and contacted two persons namely (1)Suraj Sha(20) S/O Sumit Sha of Rajender Nagar Colic Para, Ps.Pradhan Nagar, ii)Pankaj Yadav(18) S/O Munna Yadav of Coolie para near Samshān Ghat, Ps.Pradhan Nagar/Djg, and make them aware of the information in hand and requested them to act as witnesses if any search and seizure would be made necessary upon which they agreed and I gave them notice in this regard. Thereafter we along with the independent witnesses reached at Bihar Bus Stand near Siliguri Bus Terminus at 22:25 hrs.

On reaching there I contacted with my source and subsequently being pointed by my source cordoned off one person at Bihar Bus Stand under PS Pradhannagar. Thereafter we disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. As the odour of ganja was coming out from the gunny bag of his possession there was enough reason to believe that the article inside the gunny bag were ganja. Subsequently on being asked he disclosed his identity as noted above and thereafter, I gave him the written option to be searched before a Magistrate or a Gazetted Officer upon which he agreed to be searched before a gazetted officer. Consequently I contacted to the I/C Pradhannagar PS Sri Subhasish Chaki and stated him about the incident and requested him to be present at the spot as Gazatted officer for supervising search and seizure in presence of witnesses. Sri Subhasish Chaki, I/C PDN PS arrived at the spot at 22:45 hrs and thereafter the process of the search was conducted. Before conducting the search self search of mine and Sri Subhasish Chaki had been conducted by the witnesses. Subsequently on being searched from the gunny bag of the above noted accused person said to be ganja could be recovered. Thereafter I weighted the ganja recovered from the

accused person which stands total 26.860 kgs. Thereafter I seized the recovered Ganja of 26.860 kgs under proper seizure list duly signed by the accused person and witnesses. The seizure was made in between 22:45hrs to 23:50hrs . In the seizure list I obtained the signature of accused person, Sri Subhasish Chaki I/C Prdahannagar PS as gazatted officer , witnesses and put my signature too. The mother packets have been labeled as "A", and took out samples of 100 grams from mother packet and marked as A1 respectively. Consequently the apprehended persons had been arrested issuing Arrest Memo for contravening the norms of NDPS Act and returned back to Pradhan Nagar Ps.

On the above circumstance, I pray before you to start a specific case against the above noted accused person namely Bapi Singh (36) S/O Lt. Gopal Singh of Daribhit Ps Islampur, Dist-Uttar Dinajpur under proper section of law and arrange for its investigation.
