I, PSI Sailesh Subba of Bhaktinagar PS/SPC do hereby lodge a written complaint against the above noted arrested accused person to the effect that on 03.09.2021 at around 16.25 Hrs received a secret source information that three notorious drug peddlers namely Tinku Sarkar, Mohammad Hedayat and Md. Nurul Islam @ Pappu were carrying huge quantity of restricted Narcotics drugs and huge numners of vials of injections within a blue colour backpack in order to deliver the same to their Customer at Paresh Nagar behind Anandaloke Hospital. Accordingly, I diarized the matter vide Bhaktinagar PS G.D.E. No. 177, Date. 03.09.2021 and informed the matter to I/C Bhaktinagar PS/SPC and as per his kind instruction myself along with SI Prakash Saha, Constable/374 Debraj Biswas, CVF/014 Labanyamoy Barman and CVF /935 Biplab Roy of Bhaktinagar PS/SPC left for Paresh Nagar behind Anandaloke Hospital to verify the veracity of the information. On the way to Paresh Nagar I called two independent witnesses namely 1] Prasanjit Das s/o Mantu Das of Rabindra Nagar, ward No. 21, PS Siliguri, Dist. Darjeeling 2] Balaram Sikdar s/o Kesab Sikdar c/o Subash Saha of Dasrath Pally Bazaar, P.S Bhaktinagar, Dist. Jalpaiguri, and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 17.05 hrs I along with force arrived at Paresh Nagar and parked the vehicle at considerable distance and started ambushing at Mini Market near Prakash Nagar and contacted the source over phone. As described by my source, I along with my force was waiting for the said drug peddlers Mini Market, Near Pareshnagar. At around 17.45 Hrs, I saw three persons coming towards Mini Market by foot from one of the pocket route carrying one blue colour backpack by one of the person and all of them come to halt near Mini Market and was waiting for their customers. As identified by my source we cordoned from all sides and apprehended and detained all of them. I disclosed my identity as Police Officer and also my accompanying Pelice team. On being asked their name and address, they disclosed his name and identity as (1) Tinku Sarkar (26) s/o Gopal Sarkar of Darath Pally, Ward no. 41, P.S Bhaktinagar, Dist Jalpaiguri (2) Mohammad Hedayat (25) s/o Tinku Mohammad of Adarsh Nagar, Jhankar More, Ward No. 4, PS Siliguri , Dist Darjeeling. (3) Md. Nurul Islam @ Pappu (25) s/o Lt. Mohammad Aziz of Adarsh Nagar, Jhankar More, Ward No. 4, PS Siliguri, Dist Darjeeling. On further interrogation , they admitted that they were carrying contraband capsules and injection inside the blue coloured bag which they were carrying and was transporting the same to different areas of Siliguri for selling the same to drug addicts for their wrongful gain. Their admission arose strong reason to believe that the above noted person illegally possessed the prohibited cough Syrup and injections. I gave him option notice that whether he wanted to be searched in presence of Executive Magistrate or Gazetted Officer and he agreed in writing that he did not have any objection if the search be made in presence of Gazetted Officer. Then, I requested Sri Amresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station over Telephone to be present at the P.O. for the purpose of search and seizure informing the whole fact.

At 17:55 hrs Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station arrived at the P.O. and disclosed his identity to the detained person as Inspector In-Charge of Bhaktinagar Police Station under Siliguri Police Commissionerate and that he is Gazetted Officer. Thereafter, following the formalities of search and seizure in presence Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station the above two witnesses search the person of each Police personnel of our team and nothing could be found except service fire arms, wearing apparel. Then searched detained person found nothing except wearing apparel. Then, in presence and supervision of Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station and two disinterested witnesses opened the bag and found the above noted seized by tearing the carton made up of paper and found above noted seized contraband drugs. I, in presence of Gazetted officer and witnesses and Police Party demanded him valid papers / documents of said Tramadol HCI, Acetaminophen and Dicyclomine HCI, Capsules and number of Injections but he failed to produce. Accordingly, in presence and supervision of Gazetted Officer Sri Amaresh Singh, Inspector of Police

Promethazine Hydrochloride Injection I.P each bottle containing 2 ml contained in one black polyethene bag marked as "Exhibit B". Out of which one bottle Abott. Rx. Promethazine Hydrochloride Injection I.P taken as sample from "Exhibit-B" and marked as "Exhibit -B 1", 01 bottles of NRX Diazepam Injection I.P each bottle containing 2ml contained in one black polyethene bag marked as "Exhibit C". Out of which one bottle NRX Diazepam Injection I.P taken as sample from "Exhibit-C" and marked as "Exhibit -C 1". 01 bottles of NRX Buprenorphine Injection I.P each bottle containing 2ml. contained in one black polyethene bag marked as "Exhibit D". Out of which one bottle NRX Buprenorphine Injection I.P taken as sample from "Exhibit-D" and marked as "Exhibit -D 1". sealed the blue colour backpack and labelled and marked.

I, then, seized the above noted articles under proper seizure duly signed by the witnesses and acknowledge by the accused Persons by putting their signatures in seizure list. The seizure was made between 18:35 hrs to 20:15 hrs. and arrested them U/S 41 Cr.P.C informing them their ground of arrest.

On further interrogation, they admitted that they had been involved in this unlawful act since long. They also stated that they used to take mobiles from their customers and in return they used to sell drugs for their wrongful gain. They procured above noted seized articles fraudulently and was on the way to sell the same to designed customers at Siliguri area.

Under the above circumstances, the above accused violated the provision of Drugs and Cosmetics act and liable for punishment.

Hench a specific case may kindly be started against all the accused persons to meet the end of justice.
