Sir,

I, SRI SHYAM SUNDAR GOYAL, S/o Late Ramniwas Goyal, Resident of M.R. Road, Khalpara, P.O. & P.S. Siliguri in the District of Darjeeling - 734005, director of SHAKUNTALA PIPES PRIVATE LIMITED, a private limited company incorporated under the provision of the Companies Act, 1956, bearing Certificate of Incorporation No. U25200WB2010PTC141070, dated 15.01.2010, having its registered office at 3rd Mile, Sevoke Road, Siliguri, P.O. Sevoke Road, P.S. Bhaktinagar in the District of Jalpaiguri - 734008, do hereby inform you as follows:

1. That our company acquired a piece and parcel of the land measuring 5.18 Acre, appertaining to and forming part of R.S. Plot No. 80, corresponding to L.R. Plot No. 82, recorded in R.S. Khatian No. 347, Mouza - Binnaguri, recorded in Sheet No. 12, under P.S. Bhaktinagar (now N.J.P) in the District of Jalpaiguri by virtue of two Deed of Conveyance registered at the office of Additional District Sub-Registrar, Jalpaiguri and recorded in Book No. I, being Document No. 6179 for the year 2018.
2. That in the meantime, we mutated the company's name with the Record-of-Rights and the B.L. & L.R.O Rajganj have also issued separate L.R. Khatian, vide L.R. Khatian No. 1180 in our favour.
3. That due to heavy rainfall, the boundary on the northern side of the land had collapsed and hence we started repairing the same.
4. That today early morning at around 7:30 AM on 31st August, 2021 while my employed workers were repairing the broken wall, one SRI SHANKAR KUNDU, residents of Kundu Bhawan, opposite Sarada Mistan Bahandar (Sarada Delhi food Street), Bidhan
