Sir,

In producing herewith one Powertrac Tractor bearing registration no. WB-73 TC/164 Blue Colour under proper seizure list.

I, ASI. Rabi Tamang of Ambari Falakata out post, under NJP PS/SPC lodged a written complainant against the owner of the Tractor bearing registration no. WB-73 TC/164 Blue Colour to the effect that on 01.09.2021 at 14:05 hrs myself along with C/505 Tapas Dutta & NVF/068 - Amit Roy both of Ambari-Falakata OP, PS. NJP/SPC detailed for performing K-39 Mobile van duty vide GDE No. 16/21 Dated: 01.09.2021. In course of van duty at about 14: 55 hrs I received an information from my source that one Blue Colour Tractor loaded with sand coming from Karotowa River Side without any document. Accordingly I informed the matter to O/C Ambari-Falakata OP over telephone and as per his direction, myself along with force arrived at Karotowa river side on 01.09.2021 at 15: 02 hrs and found one Blue Colour Tractor loaded with sand coming from Karotowa River side. Seeing the Police party the driver of Tractor bearing registration no. WB-73 TC/164 fled away, but managed to intercept the above noted Tractor. There is sufficient reason to believe that the driver and owner of the Tractor bearing registration no. WB-73 TC/164 have stolen those sand from Kartowa river without any legal royalty/ papers as per rule, for selling clandestinely.

Accordingly, I seized the said Tractor bearing registration no. WB-73 TC/164 loaded with 15(fifteen) CFT Sand under proper seizure list. The search, seizure made in between 15:05 hrs and 15:20hrs on 01.09.2021.

I therefore request you a specific case may kindly be started against the driver and owner of the said vehicle under proper section of law.
