Sir,

In producing herewith the two arrested accused persons (i) Bappa Das (30), S/O Ajay Das of Promod Nagar, PS - Matigara, Dist - Darjeeling, (ii) Bijendar Roy (29), S/O Mani Roy of Gidda Pahar, PS - Kurseong, Dist - Darjeeling arrested u/s 41 Cr.P.C.

SI Md. Sanaullah of Matigara PS SPC lodged a written complaint to the effect that on 03.09.2021 while performing SPI. Mobile duty under Matigara PS area found Two persons namely (i) Bappa Das (30), S/O Ajay Das of Promod Nagar, PS - Matigara, Dist - Darjeeling, (ii) Bijendar Roy (29), S/O Mani Roy of Gidda Pahar, PS - Kurseong, Dist - Darjeeling were loitering near City Center, Matigara, under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Order vide No.403/2020-DM-1 (A) Date- 29.04.2021. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons namely i) Bappa Das (30), S/O Ajay Das of Promod Nagar, PS - Matigara, Dist - Darjeeling, (ii) Bijendar Roy (29), S/O Mani Roy of Gidda Pahar, PS - Kurseong, Dist - Darjeeling under proper section of law and arrange for its investigation.
