Sub-FIR in connection with car accident at Shivmandir near North Bengal University.

Sir,

I am writing this letter to file a report of an accident between TOTO and TATA Sumo gold. On 31st August, 2021 around 3:00 pm my sister **Puja Sarkar** has been met with a road accident at Shivmandir while returning from North Bengal University home. At that time she was inside the TOTO along with two other fellow passengers named **Pabitra Roy** and his fiancé **Laboni Sarkar**. According to them, TATA Sumo (bearing no **WB73C5388**) came from wrong side to rush and hit the TOTO in front. At that time 3 passengers (my sister Puja Sarkar other passengers Pabitra Roy & Laboni Sarkar) were there inside the TOTO along with the driver. Due to this accident my sister severe injury at her right leg, even the other folks also got injured. At around 3:10 PM I got a call from my sister regarding this incident that her leg got brutally injured. By that time I got the call, local people already took my sister to North Bengal Medical College, so I directly went there. As my sister's leg was swelled a lot and as she was shivering due to the hard pain, the doctor (from North Bengal Medical College) has confirmed that my sister's tibia and fibula in right leg fractured brutally. Even Pabitra Roy got 4 stitches on his head. So I intend to take my sister in Neotia Getwell Hospital. After a medial investigation by Doctor in Neotia has confirmed that it's required surgery.

As my sister's medical condition wasn't good at that time and the operation happened on 3rd September, 2021 so it got bit delayed for me to report the FIR.

I would like to file a report against the owner and driver of TATA Sumo gold. Requesting you kindly take the necessary steps as soon as possible.
