Sir,

With due respect, I, ASI Dhirendra Nath Mandal of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against (1) Krishna Singh S/O Lt. Raj Ballam Singh and (2) Satindar Singh S/O Krishna Singh both of Gadadhar pally, Panighata Road, Ps Bagdogra Dist. Darjeeling to the effect that on 30.08.21 at 17-15 hrs myself alongwith ASI Jakirul Islam, CV389 Janak singh , CV-375 Jogesh Barman , CV- 923 Pandit Nagasia CV- 386 Kishor Halder and VP-02 Pradip Roy left for Special Mobile duty vide Bagdogra Ps MCC NO. 1650/21 dtd. 30.08.21 and at 17-35 hrs received secrete source information that some anti-social activities is running in the house of alleged person Krishna Singh's house situated at Gadadharpally under Bagdogra PS, accordingly I informed the matter to O.C. Bagdogra Ps and as per his direction, myself alongwith officer and force had been to Gadadharpally and on being shown by the source at about 17-55 hrs when we went near the house of Krishna Singh to verify the veracity of the information at that time the above mentioned alleged persons came with aggressive mood and started abusive and filthy languages against the on duty police personnel. I alongwith others police personnel tried to persuade them repeatedly not to obstruct in our govt. duties. They did not try to understand anything but became more excited and started in scuffling with us and assaulted me and other on duty police personnel, as a result I alongwith some police personnel sustained grievous injuries on our bodies and the both persons fled away from the spot immediate after the incident . we were then treated at Bagdogra Primary Health Centre .

The above noted persons voluntarily obstructed Police personnel from discharge of public duty and used criminal force to cause hurt of police personnel and they also used criminal force to deter Police personnel from discharging their duties.

I therefore, pray before you that a specific case may kindly be started against the above noted accused persons and arrange for investigation.
