Sir,

In producing herewith one accused person namely Suklal Ghosh-41yrs s/o Lt Kartick Ghosh of Ganesh Ghosh Colony, Near Durga Mandir, PO Champasari, PS Pradhannagar Dist Darjeeling along with the following seized articles as per proper seizure list:

1. 20 (Twenty) no's of pet Bottles of Himalayan Gold 60up country sprit (each bottle containing 600ML)
 2. 10 (Ten) pet Bottles of Captain 60up country sprit (each bottle containing 300ML)
- All the articles packed in one big nylon bag.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Suklal Ghosh-41yrs s/o Lt Kartick Ghosh of Ganesh Ghosh Colony, PS Pradhannagar Dist Darjeeling to the effect that on 06.09.21 at 18.50 hrs received a source information from Prakashnagar near Gandhi Math under Bhaktinagar PS that one person namely Suklal Ghosh were standing near Gandhi Math under Bhaktinagar PS with huge quantity of liquor for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-357 dated 06.09.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 19.10 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 19.20hrs to 20.05hrs)

I therefore request you a specific case may kindly be started against the accused person namely Suklal Ghosh-41yrs s/o Lt Kartick Ghosh of Ganesh Ghosh Colony, Near Durga Mandir, PO Champasari, PS Pradhannagar Dist Darjeeling under proper section of law and arrange for investigation..
