Dear Sir,

I, Kausick Kumar Das, AE & Station Manager, Subhaspally CCC do hereby lodge this written complaint against (i) Azizul Haque, S/o- Lt. Kapil Mia— the manager of Bharat Financial Inclusion Limited the present user at South Shanti Nagar, P.O.- Dabgram-II, P.S. – Bhakti Nagar, Dist.: Jalpaiguri , (M) 9832946226 for unauthorised usage of Domestic connection having Con. ID : 412215423 Meter no.: P140907 for commercial purpose .Sri Ashit Das , the landlord given the premises to his tenant Azizul Haque on lease basis from approx. 1 year ago . The present user Azizul Haque, running a Financial Company styled as **Bharat Financial Inclusion Limited** use this domestic line for his office of approx. **2 KW** light, Computer, Printer & fan load illegally and unauthorisedly and thereby liable under Section 135(i)(e) of Electricity Act.

Today (06.09.2021) at 12.25 PM. I , along with Sri Malay Kumar Goswami, DE (S&LP), and Pranab Sikder , S.O.(S&LP), Darjeeling Regional Office and other supporting staff of Mobile Van had been to the above address for inspection .During inspection it is found that the said tenant Azizul Haque is consuming the electricity energy approx. present demand **2KW(approx.)** by using Domestic Connection for Commercial purpose unauthorisedly and illegally. The present reading of the said meter is 18896 units.

Accordingly, I issued a notice and served a copy to the consumer. As the unauthorized use of electricity detected, the service connection has been disconnected with removal of said energy meter, also prepare the Inspection report followed by the seizure of energy meter

(i) HPL Make, Sl. No.: P140907, (5-30)A, 1Ph meter and supplied the copies of it to the premises owner and the in presence of the Manager of the company.

Therefor , (i) **Azizul Haque** has committed an offence under Section 135(i)(e) and (ii) **Sri Ashit Das** , the landlord has committed an offence under Section 150 of Electricity Act.

So, It is requested that a case may kindly be initiated against those and arranged for its investigation.

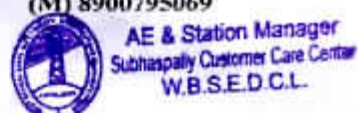
