With due respect and producing herewith 02 (two) arrested accused persons namely (1) Rahim Mandal (24 yrs) S/O Talebar Mandal of Vill- Itarvita, Howli Gaon, PS- Howli, Dist- Barpeta, Assam and (2) Saidul Islam (26 yrs) S/O Nijamuddin of 2 No Kanbari, PS- Mukalmoa, Dist- Nalbari, Assam under arrest and the following articles under seizure. The ground of arrest duly been communicated by them. :-

1. One 06 wheeler brown colour Truck (Container) having registration number TN85P3664

1. SI Goutam Malik of NJP PS, Siliguri Police Commissionerate beg to report that on 05.09.21 at 11.15 hrs I received an information that one stolen truck displaying number plate TN85P3664 is coming from Orissa and two persons stolen the said truck from Orissa. Accordingly I informed the fact to the Officer-In-Charge, NJP PS and diarized the fact in General diary vide NJP PS GDE No. 190 dtd. 05.09.21. Accordingly as per your kind order myself along with ASI Khagen Barman, ASI Sajal Das VP/08 Laxman Roy, VP/13 Jamirul Islam & CV/306 Biswajit Roy all of NJP PS left for Fulbari Toll Gate to work out the information in hand. At about 11.35 hrs we arrived at Fulbari Toll Gate and started checking vehicles coming from Ghosh Pukur side and finally at about 13.55 hrs we noticed that one container truck displaying number plate TN85P3664 is coming from Ghosh Pukur side. We give several signal to stop the vehicle but the said vehicle did not stopped there and left for Jalpaiguri side in high speed violating our signal. After a hot chase at about 14.15 hrs we managed to stopped the said vehicle at near Pradip Hotel, Gagang but driver and khalashi of the said vehicle started to flee away. But we the police party after hot chase able to apprehended them. During interrogation they disclosed their identity as noted above. On demand they failed to produce any documents in respect of the said vehicle. After thorough interrogation they admitted their guilt and disclosed that they have stolen the said vehicle and proceeded towards Assam for sale the vehicle for their wrongful gain. There was sufficient reason to believe that the vehicle is stolen one. Accordingly, I seized the said vehicle under proper seizure list and arrested the above noted two accused persons under proper memo of arrest and observing all the formalities of arrest and brought to NJP PS. There search seizure was made in between 14.45 hrs and 15.35 hrs on 05.09.21.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of law may kindly be initiated against the accused persons namely (1) Rahim Mandal (24 yrs) S/O Talebar Mandal of Vill- Itarvita, Howli Gaon, PS- Howli, Dist- Barpeta, Assam and (2) Saidul Islam (26 yrs) S/O Nijamuddin of 2 No Kanbari, PS- Mukalmoa, Dist- Nalbari, Assam and arrange for its investigation.
