Subject: F.I.R against criminal force used with the intention of risking life.

Respected Sir/Madam,

With due respect I, Hansa Pandey, wife of Lt. Upendra Pandey, resident of NJP Kathaltala more, Beside Amra Bangali Party Office, P.O.- Bhaktinagar, P.S- NJP, Dist- Jalpaiguri would like to inform you that Ruby Das, wife of Chandan Das, with the intent to cause loss and damage to my house and forcefully trying to enter my home with the intention of causing severe injury that could cause death of my family members, broke through the main entrance gate of my house. She intended to use criminal force against me and my daughters in such a manner that could have ended our life had the gate been broke open. The incident took place at around 01:30 PM to 2:00 PM on 31/08/2021, where Ruby Das was seen kicking the entrance gate of my house with full force, with the intention to break the locks and get inside my house to cause physical injury to me and my family members. Ruby Das, wife of Chandan Das, threatened me and my family of causing injury. She caused alarm to us and tried to compel us to do an act that we are not legally supposed to do. She attempted to induce criminal intimidation to us by instigating us via forceful entry into my home. She, with full force, kept banging on my house's gate until the lock broke. My daughter went to stop her from banging the gate and she Ruby Das still kept using full force on the gate and as a consequence, my daughter got badly injured on the head. She used force to pluck the tree that is located adjacent to my home's entrance gate and uprooted it successfully. Ruby Das, wife of Chandan Das, attempted to cause severe injury to me and my daughters. She kept saying that she would murder us while she kept banging on the entrance gate in order to breakthrough it. This lady, Ruby Das and her husband Chandan Das are breaching our peace since a long time.

We are a Bihari family, Ruby Das keeps telling me that she would throw my family out of the place that I live in because we are Bihari. She is totally intolerant towards my community. As a consequence, she and her companions, Chandan Das, Ganesh Das and Sanjib Paul would go to any extent to get me and my family out of the place that I, with my family, live in. They have already tried numerous tricks to torture us so that we become hopeless and sell my property to them and leave from here. The vendetta got severe when on 12/05/2020, Ruby Das, with the help of local Anti-Bihari people, had filed a false case against my son who was merely 20 years old in the same year when this happened. My son studies in Kolkata. As the pandemic took over, he had to come back to Siliguri. Ruby Das provoked me over a fight about garbage dumping. A
