Respected Sir,

I, Shyambir Singh, son of Late Kuwar Pal Singh, R/o. Lichi Bagan, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014 would like to state that today i.e. on 05.09.2021 at about 7.30 P.M. some persons namely (1) Sundar Lal, (2) Katick Lal, (3) Babu Lal, ALL sons of Topi Lal, (4) Rajes Toppo, S/o. Unknown, (5) Josheph, S/o. Unknown, ALL R/o. Lala Busty, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, suddenly stopped me on my way and physically assaulted me with stone and iron axe. On my hue and cry nearby peoples called my wife and informed about the matter. When my wife and other family members came the abovementioned persons started assaulting them also. They tried to disrobe my wife's sister namely Sita Mallick. They were using slang language. They assaulted Sita Mallick by catching her hairs. They also snatched Rs.3000/- from my T. shirt pocket and one golden locket worth Rs.7,675/- from Sita Mallick's neck. Due to their physical assault I sustained injuries on my head, back, neck and hands. These persons were shouting like hooligans and using slang language at me and my family members. I was totally shocked as I have never fallen into such problem. These

persons also threatened me with dire consequences. I and my family members are in very much trouble. Finding no other option I came before you.

It is requested before you in folded hand to kindly take strict necessary action against the abovenamed persons so that they stops harassing me & my family members.
