Sub: - Lodging of First Information Report regarding seizure of 2kg 500 grams Ganja and apprehension of two person with seized items.

It is to inform you that today on 07/09/2021 at about 1030 hrs a specific information received from UNIT INT Cell that two person are about to move with prohibited Drug items may be "Ganja " in Bihar more, Bagdogra Distt Darjeeling (WB) India. On the basis of input received, a special operation team consisting under the supervision of Shri Deepak Tomer , Assistant Commandant with INSP Satyendra nath Sarkar and 05 Other Ranks namely 1)CT/GD Anwar Ali, 2) CT/GD Niraj Kr Rawat, 3) CT/GD Jitendra kumar , 4) CT/GD Lal bd. Bohora , 5) HC/ DVR N. Samarjit Singh (Vehicle No. UP 46 G 0072) all of "F Coy Baramanirm Jote of 8th BN SSB Khaprail reached near the aforesaid place at 1100 hrs. At around 1145 hrs the party identified two person at the location near bihar more moving in suspicious manner with a medium size red/black color bag. The special operation team gave its identity to suspected person and asked about the identity of the suspected person and the items inside the bag. On opening the bag inside it found 08 silver plastic packet of suspected Ganja and 02 bag CTC Tea. When asked about the details of the suspicious item they could not give satisfactory reply and also could not give details about the source of the substance which was in their possession. The SSB OPS team asked about any authority or permission to carry the suspected Ganja but he failed to produce any letter of authority and permission. Further on the spot the substance suspected Ganja was weighed in an electronic weighting machine available in SSB Ops team and the packets found weighted 2Kg 500 grams in total 08 packets suspected Ganja and 02kg CTC tea(1kg per packet) . The substance was tested after the permission of the suspected person namely Manjula Minj with the help of drug detection kit available and drug detection kit gave positive indication of drug inside the packet. On asking them told that they had two active mobile phone with them. Then the apprehended two person were given an option whether their search would be conducted in the presence of a Magistrate or by Gazetted Officer present on the spot. they agreed for search in the presence of Gazetted Officer Shri Deepak Tomer Assistant Commandant, 8th Bn S.S.B. Khaprail. With their permission they were searched but nothing was recovered. Accordingly the suspected drug item Ganja and


the mobile phones (Samsung Phone) IMEI no. 355690114942468, contact no. 9883426799 and (Tecno in 1 Pro) IMEI 911641707378923 ,contact no 6295178338 were seized at about 1220 Hrs. During the entire process Shri. Deepak tomer, Assistant Commandant of 8th Bn SSB was present.


One sample of about 1e grams was taken from the mother packet and all the mother packet and sample packet were labelled in the presence of witness and apprehended person. The packets were sealed and labelled and signature in this regard made by the SSB OPS team members and apprehended person.

During the spot interrogation they revealed their name as 1. Manjula minj age-42 years, S/O- Nilesh Minj, vill+po Uttar patka para , P.S.+Distt-Alipur duar, (W.B.) and 2. Abhishek Roy age-19 years S/O Lalit Roy, vill+po Uttar patka para , P.S.+Distt-Alipur duar, (W.B.) . they received suspected ganja from unknown person from Alipur duar and want to deliver it in Bagdogra to unknown person . Medical examination of the apprehended two person have been carried out in Bagdogra Hospital. The complaint in this regard is being submitted along with the apprehended Two person Manjula minj & Abhishek Roy and seized articles suspected to be Ganja, two mobile phone with sim card with seizure memo for lodging of FIR in your police station under specific section of law against the apprehended two person.
