With due respect and humble submission, I SI Dawa Tshering Shepra S/o Sri Mingma Sherpa of Bhaktinagar PS, Siliguri Police Commissionerate would like report that on 03.09.2021 at about 15.15 hrs, I received an anonymous call and informed me that that some persons of Siliguri area under Bhaktinagar PS area are sharing obscene content of women without their consent and they are providing Social Escorts Service is providing through www.siliguriescorts.co.in. This refers to Bhaktinagar PS GDE No 172 dated 03.09.2021.

I accordingly informed the matter to Sri Amresh Singh, I.C. Bhaktinagar PS, SPC as per his kind order I conducted local enquiry and after gone through this website www.siliguriescorts.co.in it is seen that the agency has been transmitting the image of girl and sexually explicit act etc in electronic form styled as "ANGELS" wherein written "welcome to love babe Siliguri Escort Agency Call 9674152563 for Booking" and the agency are inviting the people of Siliguri for sexual flavour through this website and offering the social escort service round the clock and it's Manager namely Rituparna who has been providing the call girls to the customer in lieu of money for their wrongful gain, after collecting picture of girls from their social media profile and they published the same in this site for alluring the people for sexual intercourse through this website and the number of people are accessing the same hence the agency of www.siliguriescorts.co.in and manager Rituparna has been cheating to the common people by making false documents or electronic record with intent cause damage or injury a person's reputation, as the owner and its manager has been running this Sex trade through this website, where some females were engaged to have sexual intercourse with clients and they charged fair amount of money from those clients. During enquiry it appeared that the people are sharing this morphed picture of Girls through social media like, WhatsApp, fact book, instagram, etc.

Hence, I pray that a specific case may kindly be initiated against the agency of www.siliguriescorts.co.in and it's manager under proper section of law and arrange for its investigation.
