Sir,

I, Smt Pooja Kumari Saha, wife of Santosh Saha, resident of Salugara, Dimdima Busty, P.S. Bhaktinagar, would like to inform you that my marriage was solemnized with Santosh Saha on 27.02.2004 and thereafter we started to live together as husband and wife at my matrimonial home and out of our wedlock one son namely Sahil Saha and one daughter namely Sanchita Saha were born. Further I would like to inform you that after 2 – 3 months of my marriage I came to know that my husband is a habitual drinker and he consumes alcohol on each and every day. Under the influence of alcohol he used to torturing me, my son and daughter mentally and physically every day. Since six months my husband used to ask me to bring a sum of Rs. 100000/- from my parents for his business. On 01.09.2021 my husband bit my children and me with his fist and blows and he had also cut the hair of my son by scissor. My husband is an alcoholic and he drinks every day in front of my children. On 04.09.2021 at about 1 A.M. under the influence of alcohol my husband locked out me and my children outside the house in the rain, several times I knocked the door to go inside but my husband did not open the door. I further begged him to open the door for the sake of the children but he did not paid any heed to the same and accordingly we stayed outside the house at that night. My husband under the influence of alcohol everyday tortures me mentally and physically. My husband also has illicit relations with other girls he used to talk with several girls over phone everyday in the presence of children. On 06.09.2021 my husband

bit me, my son and daughter in drunken condition mercilessly and tried to kill us as such I called my in Laws to rescue me but they did not come. Today on 07.09.2021 I called my elder brother namely Chandan Prasad at my house to settle the disputes with my husband and he came to my house at about 10.30 A.M. along with his friend namely Rajesh Mahato but when my elder brother entered to the house my husband hit him two times on his head with his fist and consequently my brother fell down and again my husband started hitting my brother by kicks when he was lying on the ground then the friend of my brother namely Rajesh Mahato came to rescue him but my husband also hit the friend of my brother with his fist and blows. I and my brother went to the Siliguri District Hospital for treatment of my brother

Under the circumstances I am informing you that anything happens to me and my children in future then my husband is liable for the same. Further hope you look into the matter and do the needful and thereby I shall be highly obliged to you .
