Given the nature of the layout of allegations against the accused named in the petition, this Court thinks that the same should be investigated by the concerned Police as per the prayer of the petitioner and report about commencement of investigation, marked with treating the instant petition as FIR. It is also become evident from the petition filed on affidavit that no case has been started by concerned P.S.

Accordingly, send the petition in hand to the I/C of *Nimta* Police Station with a direction to the Inspector in Charge thereof to treat the same as First Information Report disclosing a Cognizable Offence, only after causing a preliminary inquiry and thereafter submit compliance report. It is made clear that the Police shall cause investigation as per the materials in the petition and will not be influenced by the Section of offence mentioned in the nomenclature of the petition.

Hearing that your petitioner became astonished and protested the said , then your accused no-1 started to assault him and threatened to kill him if he disclosed the matter to any body and also threatened to implicate him in a false case . There after day by day your accused no- 1 came into the rented house of your petitioner and threatened repeatedly to confind him if he would not marry her . After that your petitioner finding no other alternative left that rented house.
5. That thereafter your petitioner from her reliable sources came to know that your accused no.1 is a characterless women and it is her business to trap several persons and to earn money by making illicit relations with them.
6. That on 30.06.2021 accused no- 2 (mobile no- 9674012758& 8777318163) with whom your accused no -1 have illicit relation and that person along with accused no-1 followed me on the way and obstructed to move and after that they presurised to marry accused no-1, and demanded of Rs-2,00,000/- (Two lac) from him and when he obstructed and protested the said then they threatred him to kill and they would also implicate him in a false criminal case .

With due respect and humble submission, I beg to state that on 06.07.2021 at 22.15 hrs , duty officer of Nimta PS received a Court Complainant from the complainant Sumit Talukdar s/o Dipak Talukdar of Madhya Durganagar , Jadubhatta Sarani, 2<sup>nd</sup> bye lane, PS Nimta through Ld. ACJM Barrackpore Court vides M.P.case No. 1223/2021 against (1) Anjana Sinha Sarkar w/o Lt. Manas Sinha Sarkar of Malbazar, Jalpaiguri Budda Mandir, P.O & PS Mal Dist. Jalpaiguri A/P C/O Manik Ray of Ray Bhaban, Dakbanglo Para, Near Budda Mandir ,P.O & PS- Malbazar and (2) Subir Kar Working at 9 Crooved Lane, waterloo Street, Kol-700069 and resident at 102/7 Rabindra Sarani, Liluaha , Howrah to the effect that on 14.11.2019 the complainant contact with Anjana Sinha Sarkar through mobile and the she disclosed as she is a middle age window. There after they talked with each other. Anjana Sinha Sarkar used to call the complainant as "Dharmo Putra" and the complainant used to call her as "Dharma Ma".

In the year 2019 the complainant worked at Jalpaiguri under PS Baktinagar in the Hotel of " Gate way" as Musicine and residing there in a rented house. On 11.10.2020 the alleged person Anjana Singa Sarkar came at the complainant's rented house for celebrating the complainant's birth day. After celebrating Anjana Sinha Sarkar proposed to marry the complainant. The complainant protested against this proposal. As a result the complainant threatened and assaulted. After that the complainant left from the rented house. On 30.06.2021 the alleged person No 2 Subir Kar along with Anjana Sinha sarkar followed the complainant on the way Jalpaiguri and obstructed to move and after that they pressurized to marry Anjana Sinha Sarkar and demanded Rs. 2,00,000/- from the complainant. When the complainant protested ,they threatened him to kill. Then the complainant went to Jalpaiguri P.S and informed. After that the complainant returned at his native place and lodged a GD.

On the basis of the written complainant the above noted case was started at Nimta PS. As per endorsement of O/C Nimta PS, I took up its investigation.

During investigation of this case, I examined the complainant and other witnesses and recorded their statements U/S 161 Cr.P.C in separate sheets of paper and also visited the P.O.as per format FIR and it could be learnt that the actual P.O. is the rented house of the complainant at Anchal , wadr No. 41 , H/O Asish Kundu under PS Bhaktinagar, Dist. Jalpaiguri.I also served Notice u/s 91 Cr.P.C to the complainant.I examined the complainant he stated that the total incident has occurred at different places under Bhaktinagar PS area. The total incident has occurred under Bhaktinagar PS, Dist.Jalpaiguri , jurisdiction of The Court of Ld. CJM Jalpaiguri
