In producing herewith one acctd. (1) Suresh Sahani (40) s/o Lt. Mahabir Sahani Dadabhai Colony, ward No.43 P.S. Bhaktinagar, Dist. Jalpaiguri along with seized tractor bearing registration no WB 76 A 4625 loaded with sand.

I ASI Khagen Ch Das of Bhaktinagar PS /SPC do hereby lodge this written complaint against driver of truck bearing no WB 76 A 4625 Suresh Sahani (40) s/o Lt. Mahabir Sahani Dadabhai Colony, ward No.43 P.S. Bhaktinagar, Dist. Jalpaiguri and its owner namely Adhir Roy s/o Nal Bhalu to the effect that on 08.09.2021 at about 07.30 hrs I along with C/ 934 Mukul Bosa, C/977 Annamul Haque Saritar had been performing K-37 night Van duty vide GDE No. 421 Dated 07.09.2021 & MCC No. 720/2021 Dated 07.09.2021. While performing above noted duty on 08.09.2021 at about 07.05 hrs morning I received information from my reliable source that a truck bearing registration no WB 76 A 4625 loaded with illegal Sand collected from the river bed of Unknown river is proceeding towards Donbosco Road. After receiving information, I shared the information with I.C. BKN PS and as per his direction, I along with force hand been to near Dumping ground and managed to chased one tuck bearing No WB 76 A 4625 loaded with illegal Sand and detained and asked him to produced the valid documents in respect of the loaded sand river bed materials but the driver of the said truck failed to produced any valid documents in respect of the loaded sand and the driver of the vehicle also stated that he had loaded the sand illegally under the order of owner for the vehicle Adhir Roy s/o Nal Bhalu Roy of Shastri nagar, Near Bottle Co. More ward no.41, PS Bhaktinagar, Dist Jalpaiguri for their wrongful gain. Subsequently I seized the above noted truck along with loaded sands under proper seizure list and arrested the driver of the truck after observing all legal formalities u/s 41 Cr.P.C.

Hence under the above circumstances, I pray before your kind end that a specific case under appropriate penal section of Law may kindly be initiated against the driver of the above noted vehicle Suresh Sahani (40) s/o Lt. Mahabir Sahani Dadabhai Colony, ward No.43 P.S. Bhaktinagar, Dist. Jalpaiguri and the owner of vehicle Adhir Roy s/o Nal Bhalu Roy of Shastri nagar, near Bottle Co. More, ward no.41, PS Bhaktinagar, Dist Jalpaiguri and arrange for its investigation.
