Sir,

In producing herewith one arrested accused person namely Maheswar Sharma (32/M) S/O Late Bhola Sharma of Patiramjote, Anil nagar, PO+ PS- Matigara, Dist- Darjeeling along with one loaded TATA AC Truck bearing plate no- WB-73F/2827 is loaded with River bed Sands.

I, SI Subhendu Das of Khalpara TOP under Siliguri P.S/SPC lodge a written complaint against the above noted person to the effect that today i.e. 06.09.2021 at about 13:55 hrs while performing mobile van duty at Shanti More, Siliguri and found that one TATA AC truck having Registration No. WB-73F/2827 was loaded with illegal river bed Sands coming from Balasan Colony, Matigara side and going towards Jhankar more, Siliguri. Accordingly myself along with force managed to apprehend the said truck along with its driver and on checking the vehicle and found the trucks loaded with sands. On demand the driver Maheswar Sharma could not produce any valid or relevant documents in support of said loaded vehicle and he also failed to produce the valid documents relating to the loaded sands in the truck. Hence there was reasons to believe that the driver of the trucks had procured the vehicle along with its loaded materials illegally and transporting the same for their illegal gain.

On further grilling he discloses that he is owner of the truck in association with others of Balasan River Ghats had procured the River bed materials, sands illegally from and carrying/transporting the same to Siliguri side for their wrongful gain without any valid documents.

Under the circumstances, I seized the TATA AC trucks bearing Reg. no- WB-73F/2827 along with loaded sands under proper seizure list and arrested the drivers noted above of the truck under proper Memo of Arrest after explaining the reasons of arrest. The whole process of seizure and arrest took place in between 14:40hrs to 15:35 hrs.

Under the above, I pray before your kind end to start a case against the above arrested person namely Maheswar Sharma (32/M) S/O Late Bhola Sharma of Patiramjote, Anil nagar, PO+ PS- Matigara, Dist- Darjeeling and the both owner of the seized vehicles under proper section of law and caused its investigation.
