Sub :- Complain against the following persons for illegal occupancy of footpath and Carriage Way in front of Siliguri District Hospital and Kachari Road.

Sir,

This is to state for favour of your kind information that during regular Traffic Duty at Kachari Road as per deployment it has been noticed by me on 25th August 2021 that some hawkers are running their food stall in front of Hospital Gate and opposite side of the road obstructing the footpath and carriage way. Apart from this some hawkers also observed to run their business in footpath in both side of Kachari Road obstructing the carriage way and pedestrian movement. The matter was brought to the notice of superiors and a team from Panitanki Traffic Guard visited the shop of each and every hawkers of Kachari Road including the path in front of Siliguri Hospital and they were requested to shift their shops and free the footpath and carriage way by 05.09.2021. Today on review of the Kachari Road it has been observed that most of the hawkers have shifted or pushed back their shops except the following persons.

- 1) Sanjay Routh, Son of Late Biswanath Routh, Court More, Siliguri running a Tea stall with nicotine products in front of Hospital Entry Gate.
- 2) Laxmi Das, w/o Late Gopal Das of Rabindranagar running a Tea stall with nicotine products in the footpath adjacent to Hospital Entry Gate.
- 3) Nirajan Sarkar running a food stall in front of the entry of Siliguri District Hospital who refused to disclose his address.
- 4) Swapan Saha, s/o Late Mangal Saha of Tilaksadhu More, Siliguri running a Tea shop in the footpath adjacent to the Entry of Siliguri District Hospital.
- 5) Rajesh Singh, s/o Gautam Singh of Rana Busty of Bagrakot Siliguri running a Tea stall in the foot path adjacent to entry point of Siliguri District Hospital.
- 6) Paritosh Mallick resident of Khirmohan Mallick, Lichupara, Court More running a Tea Stall in the footpath adjacent to the entry point of Siliguri District Hospital.
- 7) Shiva Basfore of Pramod Nagar running food stall opposite the entry of Siliguri District Hospital.
- 8) Sudip Sen, son of Sadhan Sen of Bholu More, Fulbari running food stall opposite the entry of Siliguri District Hospital.
- 9) Jiban Thakur, s/o Sudhangshu Thakur of Pramod Nagar running food stall opposite the entry of Siliguri District Hospital.
- 10) Pradip Das, s/o Bijay Das of Matri Sadan, Dabgram running food stall opposite the entry of Siliguri District Hospital.
- 11) Amit Mohanta, s/o Anil Mohanta of Simultala, Matigara running his flower stall in front of Mayer Echha Kalibari.
- 12) Ranjan Sah, s/o Laxman Sah of Dinabandhu Mitra Sarani, Subhash Pally running his flower stall in front of Mayer Echha Kalibari.

Under the circumstances, necessary action may kindly be taken against the above mentioned with appropriate section of law for obstruction of pedestrian way, carriage way and for running their business without any valid documents.
