Sir,

In producing herewith one (02) arrested persons named (1) Subodh Roy (22), S/O- Lt. Dilip Roy of Patiramjote, PS. Matigara, Dist Darjeeling and (2) Apan Das (27) S/O Dijen Das of of Patiramjote, PS. Matigara, Dist Darjeeling along with one Mahendra Bollero Pick Van bearing Regd. No- WB-73F-3709 loaded with sand (approx 100 cft.) I, ASI- Bikash Ror of Siliguri P.S., Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons named Subodh Roy (22), S/O- Lt. Dilip Roy of Patiramjote, PS. Matigara, Dist Darjeeling and (2) Apan Das (27) S/O Dijen Das of of Patiramjote, PS. Matigara, Dist Darjeeling Driver and helper of vehicle no- WB-73F-3709 and Owner of the vehicle no- WB-73F-3709 and others to the effect that on 07.09.2021 at 11.05 hrs while performing K-21 mobile van duty vide Siliguri PS GDE No- 392 dated 07.09.2021, found the above noted vehicle (WB-73F-3709) coming from Bardawan Road side being loaded with sand and subsequently intercept the vehicle baring Regd. No- WB-73F-3709 at Milanpally near Children Park, Siliguri being driven by the above mentioned person. On being asked the driver and helper of that vehicle disclosed his identity as above and being demanded he failed to produce any valid documents/papers for carrying the sand. On being further interrogated the driver of the vehicle bearing Regd. No- WB-73F-3709 named Subodh Roy and Apan Das admitted that they in connivance with the owner of the vehicle and others was carrying the sand by illegal means for their wrongful gain. Accordingly I seized the vehicle i.e., vehicle bearing Regd. No- WB-73F-3709 being loaded with sands (approx 100 cft.) and subsequently arrested the driver named Subodh Roy and handymen Apan Das.

Hence, I pray that a specific case may kindly be started against the above noted persons named (1) Subodh Roy (22), S/O- Lt. Dilip Roy of Patiramjote, PS. Matigara, Dist Darjeeling and (2) Apan Das (27) S/O Dijen Das of of Patiramjote, PS. Matigara, Dist Darjeeling and owner of vehicle no- WB-73F-3709 and others under proper section of Law and arrange for its investigation.
