Sir,

In producing herewith one (01) arrested person who disclosed his identities namely Manish Kr. Jha (21 yrs ) S/O Late Joy Kishor Jha of Champasari, Jyotinagar, PS- Proadhan Nagar, Dist- Darjeeling along with the following seized articles, seized under proper seizure list, duly attached herewith viz:

- i) One (01) Carton Box of "Cefrex" Cough Syrup ( Chlorpheniramine Meleate & Codeine Phosphate Syrup) containing 102 bottles @ 100 ml each wrapped with white Cello tape marked as Exhibit-A having batch no. TBHU0232,
- ii) Two bottles of "Cefrex" Cough Syrup ( Chlorpheniramine Meleate & Codeine Phosphate Syrup) containing 100 ml each taken as sample from the exhibit-A and marked as Exhibits-A1.

I, SI Uday Chakraborty of Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against Manish Kr. Jha (21 yrs ) S/O Late Joy Kishor Jha of Champasari, Jyotinagar, PS- Proadhan Nagar, Dist- Darjeeling to the effect that on today ie on 07.09.21 at 19.35 hrs I have received a specific source information that one person is standing with carton box containing huge quantity of contraband Cough Syrup at Bagrakot Bus Stand area for disposing the same for his wrongful gain. The matter has been diarized vide Siliguri PS GDE No.429 Dt- 07.09.21. Accordingly, I informed the matter to Sri Sudip Chakraborty, Inspector-in-Charge, Siliguri Police Station, SPC in writing a letter to him and expressed the entire information, accordingly he directed to me to work out the information immediately. Hence at about 19.55 hrs as per his kind direction myself along with PSI Rajiv Subba, SI Hiru Kanti Sarkar, ASI Siben Sarkar, ASI Subir Sen, CV/283 Prosenjit Dey and CV/622 Ramanth Barman all of Siliguri Police Station, Siliguri Police Commissionerate left for Bagrakot Bus Stand area to verify the veracity of the information vide M C C. No. 440/21 Dt. 07.09.21 which refers to GDE No. 430 Dt. 07.09.21 by Govt. Vehicle No. WB 61A0137 driven by CV/285 Krishna Yadav.

At the time of departure from PS, I took envelope, white paper, sealing wax, gum, seal, etc. At about 20.05 hrs we reached at Bagrakot area near Auto Stand & kept our vehicles at a distant. Subsequently we called two independent witnesses namely; (1) Surajit Banerjee (36) S/O Sri Atul Banerjee of Subhashpally, Lichubagan, Ward No. 18, PS- Siliguri, Dist- Darjeeling and (2) Ratan Das (34) S/O Sri Tarun Das of Subhashpally, Lichubagan, Ward No. 18, PS- Siliguri Dist- Darjeeling and disclosed our identities and informed them about the information in hand and requested them in writing to accompany us to witness the Police action. They agreed & gave in writing about their consent to accompany Police during the raid.

Then, as per source information, we approached towards Bagrakot Bus Stand area & as per identification by source I managed to cordoned the place and found that the above noted person was standing there with carrying a Carton box. Accordingly we detained him.

After disclosing our identities, in presence of independent witnesses we had a strong reason to believe that the detained person was carrying contraband Cough Syrup in his exclusive

possession for disposing the same at Bagrakot Bus Stand in concealed manner for supplying/selling the same in Siliguri and its adjacent area for his wrongful gain. On being asked he disclosed his identity as noted above and admitted that he possessed contraband Cough Syrup. Then I gave him option in written whether he wanted to be searched in presence of Executive Magistrate or any Gazetted Police Officer. He agreed to be searched by one of them. Further, I served him option notice in accordance with provisions of law in this regard in writing and he also gave his approval of being searched by any one of them in writing on the notice served to him. Then I informed the matter to I.C. Siliguri PS & I requested him to come at Bagrakot Bus Stand area to remain present and supervise the search, seizure and label being a Gazetted Police officer. Accordingly, at 20.45 hrs Sri Sudip Chakraborty, I. C. Siliguri PS arrived at the spot in uniform and disclosed his identity to the detained person as well as to the witnesses as a Gazetted Police Officer. I also offered the independent witnesses and the accused person to search our Police Party as per provision of law. But he refused to search the police party. Under supervision of Sri Sudip Chakraborty, Inspector -In-charge, of Siliguri Police Station, SPC and in presence of two independent and dis-interested public witnesses, searched the detained person following all formalities keeping his decency but nothing could be recovered on his person except his wearing apparels. Then, I opened the one carton box and found that the above seizure articles kept concealed in the said carton box wrapped with plastic which is not visible from the outside. Then the detained person confessed that he was carrying these box in concealed manner for selling/supplying to young boys at Bagrakot and its adjacent area. On demand in presence of the Gazetted Police Officer, Sri Sudip Chakraborty, I. C. Siliguri PS, he failed to produce any valid document in support of possessing of the said contraband Cough Syrup which was holding by him.

Accordingly I counted the said Cartoon box containing Cough Syrup, which was found in the possession of the above noted detained person and found total 102 bottles of "Cefrex" Cough Syrup (Chlorpheniramine Meleate & Codeine Phosphate Syrup) containing 100 ml each marked as Exhibit- A, and also collected two bottles of said contraband Cough Syrup containing 100 ml each as sample taken from Exhibits A and marked as Exhibits A1. Then, I seized the above noted articles under proper seizure list and labeled, duly signed by the above noted witnesses, Police personnel and the Gazetted Police Officer, Sri Sudip Chakraborty and duly acknowledge by the detained person. I also supplied a copy of seizure list to the detained person. The whole search, seizure & label was made in between 21.05 hrs and 22.55 hrs. On further asked the apprehended person confessed in presence of Gazetted Police Officer, Sri Sudip Chakraborty, I.C Siliguri PS and other witnesses that he procured the said seized Cough Syrup from Ashgarh side for the purpose of illicit gain. On interrogation he disclosed that he had been dealing in such business of selling the said Cough Syrup illegally since long. Then I arrested the above noted accused person after observing all guidelines of Apex court.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely; Manish Kr. Jha (21 yrs ) S/O Late Joy Kishor Jha of Champasari, Jyotinagar, PS- Prodhian Nagar, Dist- Darjeeling.
