I, Asmin Khatoon (Mobile 7548921324) wife of Afijul Islam, Daughter of Md. Kayum, resident of Netaji Nagar, Near- Madarsa, Ward No. 42 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri beg to report you the following facts:-

1. That Afijul Islam son of Soleman Houque of Prakash Nagar, Pramod Nagar, Near- Tower Building, Ward No. 42 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri is my legally married husband. My marriage was solemnised with him on 26.01.2020 at my father's house at Netaji Nagar, Near- Madarsa, Ward No. 42 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, according to Muslim Law, rights and customs.

After marriage I started to live/reside my husband together as husband and wife in my in laws house at Prakash Nagar, Pramod Nagar, Near- Tower Building, Ward No. 42 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri.

At the time of marriage my Parents gave cash Rs. 2,00,000/-(Rupees Two Lac), different Gold Ornaments total weigh 2 voris, different Silver ornaments total weigh 10 vories, different furnitures including wooded double bed cot, dressing table, dyning table with chairs etc total worth Rs.1,50,000/- (Rupees One Lac fifty thousand) and different utensils and cloths total worth Rs.30,000/- (Rupees thirty thousand) to my husband as per his demand and the demand of his parents.

They were not satisfied with the aforesaid dowry cash amount and articles, so they started to demand more cash and articles and gold

ornaments from us soon after my marriage. I could not full fill their demand.

So, my husband, my Parents- in- law and my Two Nanads (Sisters -in - Law) Saira Banu and Sajida Khatoon started to tortured upon me both physically and mentally in different ways.

- 2. That out of my said wedlock relation with my husband Afijul Islam I gave birth a male child on 21.10.2020 whose name is "Yasin Islam".
- 3. That my husband, my mother-in-law Amina Bibi, my father-in-law Soleman Houque and aforesaid two Nanads namely Saira Banu and Sajida Khatoon continued to tortured me both physically and mentally.
- 4. That my aforesaid Nanads (Sisters-in-law), their husbands namely Majnu Sekh [husband of Saira Banu] and Unknown [husband of Sajida Khatoon] also started to torture me both physically and mentally with them constantly.

They all always use to physically assault me by fists and blows and by kicks and always use to pick- up quarrel with me without any reason and use to abuse me by filthy and insulting languages. Due to their such continuous physical assault, I sustained injuries on my person several times and I digested and tolerated pain on my body and the aforesaid tortures silently.

But they continued to torture upon me in such ways.

5. That they use to abuse my son in my presence by filthy languages which give tremendous pain in my mind and body.

They do not supply/give proper food and clothes to me and my son and several occasion they compelled us to remain us in starvation.

- That in such way they continued to torture me both physically and mentally.
- 7. That thereafter my husband along with me and our son to live/reside at rental house at Dhaknikata, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling.

- 14. That due to such continuous assault upon me and due to their such attempt to murder me in such cruel manners, I sustained severe injury on my persons and I was medically treated at Siliguri District Hospital and still I am under medical treatment.
- 15. That due to my serious illness caused due to such assaulted by them upon me delay is caused for lodging this FIR which may kindly be condoned.
- 16. That the Xerox copy of medical treatment paper is enclosed here with.

I therefore request you to kindly take necessary steps against the aforesaid culprits i.e., against my husband and my aforesaid in- laws for the commission of the aforesaid offences upon me.
