Subject :- FIR against Amal Barman(Male), Age 30(approx) for carrying out unauthorized activity in close proximity to 11KV HTOH line in the premises of Arsati Gupta, Consumer ID-412050220, Meter No -L2326707 near Vanga pool, Gurung Jote, himul, PO-Nimai, Matigara, Darjeeling leading to electrocution (Non-Fatal) on 04.09.2021 at around 03:45 PM under Siliguri Sub-Urban Division.

Sir

I, Arka Mondal, S/O Sanjay Mondal posted as Divisional Engineer(E) at Siliguri Sub-Urban Division would like to inform you that on 04.09.2021 a non fatal electrical accident occurred iro Amal Barman(Male), Age 30(approx) near vanga pool, Gurung Jote, himul, PO-Nimai, Matigara at around 03:45 PM. The incident occurred as reported by HT mobile van of Khaprail 33/11 KV Substation & local residents that while performing civil/construction work in the premises of Arsati Gupta, Consumer ID-412050220, Meter No -L2326707, the victim got electrocuted.

As gathered from the local public the victim were performing construction work in the premises of Arsati Gupta where while lifting a piece pipe for roof construction of the shed of the building the metal pipe came in close contact with the live line (Patiram 11KV Feeder-Khaprail Substation) leading to huge sparking & electrocution of the victim along with tripping of the said Patiram 11 KV feeder. After getting electrocuted victim leaves the pipe immediately, and the victim was taken to Matigara Hospital for treatment by the local inhabitants of the area.

It may be stated here such kind of activity of working in the close vicinity to our live lines is totally unauthorized & condemnable by law. As the work was being carried out in such a casual manner, such incident would have been taken place. Such kind of mal practices leads to accidents. Hence you are requested to take necessary action accordingly. Thanking you.
