Sir,

I S.I. Kalipada Barman of Matigara P.S do hereby lodge a Complaint to the effect that on 05.09.2021 at 13:55 hrs I received a information from reliable source that 01 (One) Tata Ace. No. WB - 73 E 5951 (TATA ACE) loaded with river bed materials coming from Khaprail Bazar. On receiving the information I along with available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Dimajote under Matigara P.S area, I found 01 (One) Tata Ace. No. WB - 73 E 5951 loaded with river bed materials from Lenin Colony going towards Matigara. Subsequently, I manage to stop the vehicle and found the driver with bed materials with no valid documents and after interrogation he disclosed his identity as Arpan Gupta, S/O Lt. Ram Badan Gupta of Iskon. Therefore I seized the above noted loaded trucks under proper seizure list in between 14.15 hrs to 14.55 hrs and arrested the driver u/s 41 Cr. P.C. in presence of available witnesses as stolen recovery property loaded river bed materials and brought to the above noted bricks at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle and the seized vehicle under proper section of law and arrange for its investigation.
