In producing herewith two (02) arrested accused persons namely (i) Hari Sankar Sah (37 yrs), s/o - Lt. Satya Narayan Sah of Rupwali Gopi, PS- Dhaka, Dist - Motihar, Bihar (ii) Pankaj Kumar Pandey (35 yrs), s/o - Lt. Ramu Desh Pandey of Jathudey Gaihat, PS- Bheniber, Dist - Mujaffarpur, Bihar under arrest along with seized articles viz. (i) 06 (six) no sealed bottles of Imperial Black Masters Select Grain Blended whisky each bottle containing 750 ml. (ii) 02 (two) no sealed bottles of Mc.dowells no 1 Luxury premium whisky each bottle containing 750ml. (iii) 10(ten) nos sealed bottles of K.D 50 whisky each bottle containing 750ml. (iv) 40(forty) no's Sealed bottles of Imperial Blue superior grain whisky each bottle containing 375 ml. (v) 47(forty seven) no's sealed bottles of imperial Blue superior grain whisky each bottle containing 180ml. (vi) 40(forty) no's sealed bottles of Mc.Dowells No 1 Luxury premium whisky each bottle containing 180ml.

I ASI Dipak Singha of Milanpally OP under NJP PS/SPC do here by lodged a written complaint to the effect that today on 07/09/21 at 00:05 hrs acting on a tip-off source information myself along with ASI Biswajit Adhikari, ASI Bhim Narayan Singh, C/- 1052 - Dipaak Das, had been to Canal road near Teesta Barrage under Milanpally OP boarding in a PS govt. Vehicle to work out the information that a huge number of country spirit are carrying by two unknown miscreants by a Private bus namely Raj Travel without license to sale the same in Siliguri and Bihar. This refers to Milanpally OP GDE No- 178, dt-06/09/21. On arrival at Canal road near Teesta Barrage I summoned two local witnesses to witness the raid and on being identified by the engaged source we held raid in the bus namely Raj Travel and could recover the above noted huge amount of ID liquor. During raid the above noted accused persons were arrested from whose exclusive possession the above noted liquors were found. The entire articles were kept hidden in a big size gunny bag and concealed in the back side of the bus. On demand they could not produce any license/documents in support of their possession. On interrogation they admitted that they have been running the business clandestinely since long. Accordingly I seized the above noted liquors under proper seizure list and arrested the accused persons and took into the custody. The seizure and label was made in between 00.25 hrs to 00.45 hrs.

Hence, I pray that a specific case under proper section of law may kindly be initiated against the accused persons namely Hari Sankar Sah (37 yrs), s/o - Lt. Satya Narayan Sah of Rupwali Gopi, PS- Dhaka, Dist - Motihar, Bihar and Pankaj Kumar Pandey (35 yrs), s/o - Lt. Ramu Desh Pandey of Jathudey Gaihat, PS- Bheniber, Dist - Mujaffarpur, Bihar.
