Sir,

I SI Debabrata Khan of Bagdogra PS, Siliguri Police Commissionerate do hereby lodge written complaint to the effect that on 31.08.21 at 19-15 hrs Aman Kumar singh, flight Lieutenant, Adjutant for commanding Officer of 142 SSS Flight, Airforce C/O Air Force Station, Bagdogra submitted a written information that 984488-T LAC Amit Kumar structure fitter, s/o Late shivpal Singh of Air Force Station Bagdogra (to work with 142 Support Survival and Security Flight) shot himself at 16-50 hrs on 31 August- 21 with service rifle, which was issued to him for the purpose of carrying out guard duty. His body found lying in guard rest room. Over this written information started Bagdogra PS UD case No. 17/21 dtd. 31.08.21 and endorsed to me. Accordingly I alongwith force left for Air Force Station Bagdogra to prepare surathal report over the dead body of deceased Amit Kumar and at 19-35 hrs I alongwith force arrived at the said place and started investigation and found that the dead body of deceased Amit Kumar is lying on the floor with gunshot injury in the Guard rest room and the Gun was lying next to him, during searching I recovered a suicide note from the said room. Accordingly I seized (1) INSAS Rifle 5.56 having Butt No. 10 and body No. 17109119 (2) 37 (thirty seven) live ammunition (3) 02 (two) magazine of Insas Rifle (4) 03 (three) fired empty cartridge and during searched of the said guard room, I recovered one suicide note written in Hindi languages and one VIVO mobile set which also seized by me as per proper seizure list. The I prepared Surathal report over the dead body of deceased Amit Kumar and forwarded the dead body of deceased Amit Kumar with all connected papers through escort constable 851 Chandan Debnath to the Head of Department of FSM, NBMC & Hospital for holding PM examination to ascertain actual cause of death vide Bagdogra PS Maffasal MCC No. 01/21 dtd. 31.08.21.

Today on 09.09.21 I collected P.M. examination report over the dead body of deceased Amit Kumar and on perusing it could be learnt that the Dr. Dibyakar Chhetri, demonstrator, Deoptt, if F,M & Toxicology, N.B. Medical College opined that "death was due to the effects of firearm injuries noted in P.M. examination report, antemortem in nature".

On perusing the suicidal note which recovered and seized from the Place of occurrence in which the deceased allegation against his wife and others in laws for his death and also noted that the deceased Amit Kumar committed suicide in consequence of abetment by the alleged persons namely (1) his wife Sunita Garwal, (2) Sontosh Garwal (Father in law), (3) Indrajit Garwal (brother in law) and (4) Mother in law. Accordingly I informed the matter to the department of 142 SSS Flight, Airforce C/O Air Force Station, Bagdogra and also house inmates of the deceased.

I therefore, pray before you that a specific case may kindly be started against Sunita Garwal (wife), Sontosh Garwal (Father in law), Indrajit Garwal (brother in law) and Mother in law and arrange for investigation.
