Sir,

I, Prashanta Kumar Mahato, S/O Mr. Dilip Kumar Mahato, presently Assistant Engineer and Station Manager, do hereby lodge this complaint to the effect that today at about 12:00 hours in pursuance of a secret information regarding theft of electric energy myself along with Sri Malay Goswami, Sri Pranab Sikdar and other technical personnel had been to the spot at Tara Sankar bye-lane Deshbandhupara, in the residential house of Mr. Bhagat Mahato, Tara Sankar Road bye-lane Deshbandhupara. After issuing notice to the representative of Mr. Bhagat Mahato, we enter the premises of Bhagat Mahato. On checking, it was found that there were two energy meters in the name of Anjali Mahato and Bhagat Mahato. Anjali Mahato (Con ID: 402575050, Meter No.: BB0984435) was providing power to Mr. Bhagat Mahato, whose domestic connection (Con ID: 412085210 and Meter No.: L1015090) was disconnected due to non-payment of Outstanding dues of Rs.34,820 on 30<sup>th</sup> January, 2021.

According, Anjali Mahato has committed an offence u/s 135/ 1 (e) of the Electricity Amendment) Act 2007. She did this intentionally, motivatedly with malafied intention for his wrongful gain.

After that, we disconnected and removed both the energy meters of Anjali Mahato (Meter No.:BB0984435) and Bhagat Mahato (Meter No.: L1015090). We, prepared inspection memo and seizure list by seizing the meters in-question in presence of witnesses and supplied copies of it to the representatives of the premises owner. So, it is requested to start a case u/s 135(1)(e) of Electricity Act against Anjali Mahato and arrange for its investigation
