In producing herewith One accused person namely Gour Das @ Kalu (32) S/o Bana Das of Santipara, Po- Bhaktinagar, PS- NJP, Dist.- Jalpaiguri along with the following seized articles under seizure as per seizure list:

1. Total 05 (Five) packets wrapped with Transparent White and Brown color plastic Cello Tape containing Total 58 kgs (Fifty Eight) Kg said to be Ganja Marked as follows –

- i) Exhibit- 'A' Contains 12 Kg. Said to be Ganja wrapped in a transparent white Cello Tape.
- ii) Exhibit- 'B' Contains 12 Kg. Said to be Ganja wrapped in a transparent white Cello Tape
- iii) Exhibit- 'C' Contains 12 Kg. Said to be Ganja wrapped in a transparent white Cello Tape
- iv) Exhibit- 'D' Contains 12 Kg. Said to be Ganja wrapped in a transparent white Cello Tape
- v) Exhibit- 'E' Contains 10 Kg. Said to be Ganja wrapped in a Brown Cello Tape.

2. One White Color Bolero Pickup bearing registration No. WB 73 C 3130.

I, SI Ajay Pradhan of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused person to the effect that on today i.e 09.09.2021 at about 1715 hrs received a specific source information that one person would be coming from Coochbehar side and proceed towards New Jalpaiguri side with a suspected consignment of Ganja in one vehicle bearing registration No. WB73C 3130. Accordingly I informed the matter to SI Samir Tamang, O/C New Jalpaiguri PS, SPC and requested him to strengthen by more police personals at Santipara. Hence, I, diarized the fact in GDE vide NJP PS GDE No. 430 dated: 09.09.2021 and at 1720 hrs I, along with ASI Khagen Barman, C/ 453 Uttam Dey, NVF-0192 Chandan Roy VP/13 Jamirul Islam, VP/08 Laxman Roy all of NJP PS left PS for Santipara, vide vide GDE NJP PS GDE No: 431 Dated: 09.09.2021 & NJP PS M.C.C. No. 1721/21 Date: 09.09.2021 to verify the veracity of the information by Govt. Vehicle taking necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. At about 1735 hrs we reached at Santipara and parked the vehicle at considerable distance and proceeded towards Kali Mandir. Meanwhile, I called two disinterested witnesses namely 1) Hari Das Biswas S/o Lt. Hari Krishna Biswas of Fulbari Bazar, Po- Fulbari hat, PS- NJP, Dist- Jalpaiguri 2) Saumya Bikash Ghosh S/o Jyoti Prakash Ghosh of PurbaDhantala, PS- NJP, Dist.- Jalpaiguri. I disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure, if any. Meanwhile, our Police party started looking for accused persons and finally at 1815 hrs we saw one vehicle bearing registration no. WB73C 3130 coming from Uttarkanya Side and proceeding towards Santipara Side. We stopped the vehicle bearing registration no. WB73C 3130.at Santipara in front of Kali Mandir driven by the above noted accused person and asked the driver to park the vehicle beside the road. I disclosed our identity to him. On being asked he disclosed his names and address as noted above. I told him about the information in hand but he denied. After prolong interrogation, he admitted that there is Ganja kept in secret chamber in front seat of the vehicle. Then I gave him option that whether he wanted to be searched in presence and supervision of Executive Magistrate or Police Gazetted Officer and he agreed to be searched in presence of Police Gazetted Officer. Accordingly, I served the Notice in writing and as per provision of law to him which he duly acknowledged by receiving and signing in the copy of Notice. Accordingly, I informed Sri Pasang Tobgay Bhutia, WBPS, ACP-Traffic (West), SPC rewarding the apprehension of said person with said to be Ganja and requested him through messenger to come at Santipara, NJP and remain present as Gazetted Officer during the time of search and seizure if any which he duly accepted. At 1905 hrs Sri. Pasang Tobgay Bhutia, WBPS, ACP-Traffic (West), SPC arrived at the spot in uniform and disclosed his identity to the detained person as well as witnesses as a Gazetted Officer, Sri. Pasang Tobgay Bhutia, WBPS, ACP-Traffic (West), SPC I also offered the independent witnesses and the accused person to search me and our Police Party as per provision of law. But he refused to search the police
