Subject: FIR

In producing herewith one namely Nitesh Kumar(23) S/O Shiblal Sahani of Khaprail Bazar, P.O- New Chamta, P.S- Matigara, Dist-Darjeeling along with one seized vehicle bearing no- WB- 91 1194 (Tractor) loaded with river bed materials under proper seizure.

I, PSI Newton Biswas of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the driver cum owner of vehicle no WB- 91 1194 loaded with river bed materials to the effect that today on 13.09.2021 at 08.55 hrs while performing raid duty vide MTG PS GDE No-654 dated -13.09.2021 along with force it was found that the above noted Tractor vehicle loaded with river bed materials was coming from Fulbari Patan side towards Khaprail Bazar Matigara side . As such I detained the above noted vehicle at Fulbari Patan, Matigara being loaded with river bed materials driven by the above mentioned person. On being asked the driver of that vehicle disclosed his identity as noted above and being demanded he failed to produce any valid documents/papers for carrying the river bed materials. On being further interrogation the driver of the vehicle bearing Regd. No- WB- 91 1194(Tractor) named namely Nitesh Kumar(23) S/O Shiblal Sahani of Khaprail Bazar, P.O- New Chamta, P.S- Matigara, Dist-Darjeeling stated that he is involved in carrying of river bed materials by illegal means for his wrongful gain since last few months and also stated that he is the owner of the vehicle. Accordingly I seized the vehicle i.e., vehicle bearing Regd. No- WB- 91 1194 (Tractor) being loaded with river bed materials and subsequently arrested the driver named Nitesh Kumar(23) S/O Shiblal Sahani of Khaprail Bazar, P.O- New Chamta, P.S- Matigara, Dist-Darjeeling . The whole process of seizure and arrest was made in between 09.25 hrs to 09.55 hrs.

Hence, I pray that a specific case may kindly be started against the driver namely Nitesh Kumar(23) S/O Shiblal Sahani of Khaprail Bazar, P.O- New Chamta, P.S- Matigara, Dist-Darjeeling cum owner of above noted vehicle bearing no- WB- 91 1194 (Tractor) loaded with river bed materials under proper section of Law and arrange for its investigation.
