Sir,

In producing herewith two accused persons namely 1) Subrata Ghosh (23), S/O-Subhash Ghosh and 2) Sudip Ghosh @ Roni(31), S/O-Subhash Ghosh both of Rupsingh Jote, PO+PS- Bagdogra, Dist- Darjeeling along with following seized articles viz.,

- 1] One Certificate of Registration in the name of Ganesh Rai, Showing registration No. WB74M3914, Chassis No. MD2DHDHZZPCH69702 and Engine No. DNGBPH08900.
- 2] One black colour Pulsar 150 CC Bike affixing registration No. WB74M3914 and having Engine No. DHZRGL21714, Chassis No. *MD2A11CZ9GRL23318*.

I, PSI Shekhar Adhikary presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted person that on 13.09.2021 in course of Night patrolling duty received a reliable source input that two persons was coming towards Phansidewa more under Matigara PS from Chathat medical more riding a black colour Pulsar 150 CC Bike affixing a false number plate. Subsequently myself along with assisting force reached at Phansidewa more and being pointed by my source I detained two persons who were riding a black colour Pulsar 150 CC Bike affixing registration No. WB74M3914 and being asked disclosed their identity as above. The above noted Subrata Ghosh was riding the said bike and Sudip Ghosh @ Roni was found as pillion rider. On demand they produced a Certificate of Registration in the name of Ganesh Rai, Showing registration No. WB74M3914, Chassis No. MD2DHDHZZPCH69702 and Engine No. DNGBPH08900 in respect of the Bike they were riding on. But after proper observation it revealed that the said Bike bears Engine No. DHZRGL21714 and Chassis No. *MD2A11CZ9GRL23318* which does not matches with the affixing registration No. WB74M3914. Subsequently after prolong interrogation both the apprehended persons namely Subrata Ghosh and Sudip Ghosh @ Roni stated that they along with others associates dishonestly acquire Bikes and fraudulently makes documents as well as number plate in respect of those Bike and sell the same for their wrongful gain. Accordingly I seized the said black colour Pulsar 150 CC Bike affixing registration No. WB74M3914 and having Engine No. DHZRGL21714, Chassis No. *MD2A11CZ9GRL23318* as well as its false documents i.e. Certificate of Registration in the name of Ganesh Rai, Showing registration No. WB74M3914, Chassis No. MD2DHDHZZPCH69702 and Engine No. DNGBPH08900 under proper seizure list in presence of available witnesses and also arrested both the apprehended persons namely 1) Subrata Ghosh (23), S/O-Subhash Ghosh and 2) Sudip Ghosh @ Roni(31), S/O-Subhash Ghosh both of Rupsingh Jote, PO+PS- Bagdogra, Dist- Darjeeling following all formalities.

Therefore, I pray before your good self that a specific case against the above noted accused persons namely 1) Subrata Ghosh (23), S/O-Subhash Ghosh and 2) Sudip Ghosh @ Roni(31), S/O-Subhash Ghosh both of Rupsingh Jote, PO+PS- Bagdogra, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
