With due respect I **SHRI DEBAGNI CHOWDHURY** beg to inform you that I have purchased a mobile (One Plus Nord 2 5G) on 29/03/2021 through Amazon.in, that on 05/09/2021 the said mobile got switch off automatically. Thereafter I went to Rare Enterprises (Phixman.com) Ground floor, Planet Mall, Opposite Cosmos Mall, beside PC Jewelers, Siliguri, West Bengal 734001 and I have shown my mobile to Shri Akshay More, who introduced himself as authorized person of the said shop and farther told me that the said shop and farther told me that the said shop is the authorized service center of one plus mobile. Thereafter I handed over the said mobile to Shri Akshay More and he issued a device receiving form vid Order ID: 731037775 dated 05.09.2021 and demanded a sum of Rs. 5,000/- from me after handing over the said mobile to him I came back home. After one and a half hour I called him and he said that it would take at least 7 days to repair as the authorized engineer of One Plus mobile will come and check the mobile. Today, I came to know about the original service centre of One Plus mobile situated at QDIGI- Siliguri AEIOU's Mobile Care Chowdhury Mini Market, Opp. Hotel Dolly Inn, Bidhan Road, Siliguri, and West Bengal 734001. Thereafter, I went there and came to know that there is no other One Plus authorized service centre except QDIGI. Thereafter I went to Rare Enterprises (Phixman.com) and asked Shri Akshay More as why he falsely represented as authorized person of One Plus mobile. Thereafter he returned my mobile and took back the original device receiving form from me. Thereafter I handed my mobile over to QDIGI and after verifying the said mobile they informed me that the back cover was opened forcefully and the seal was broken so the warranty could not be given and they further gave an estimate of Rs. 21,374/-. Thereafter today at 1:40pm I went to Rare Enterprise and met with Shri Akshay More and informed the matter to him but he threatened me with dire consequences and cheated me.

So, I request you to take necessary legal action against Shri Akshay More of Rare Enterprises (Phixman.com) Ground floor, Planet Mall, Opposite Cosmos Mall, beside PC Jewellers, Siliguri, and West Bengal 734001.
