I, Peter Paul Ekka, s/o Shantilal Ekka, resident of Maryview T.E., P.O. - Hatighusa, P.S. - Naxalbari, Dist - Darjeeling, would like to inform you that today, ^{date - 08/09/2021} around 1:30 pm my friend Albart Tirkey, s/o Regius Tirkey, resident of Jangaram T.E., P.O. & Bagdogra, Dist - Darjeeling and I were going to Malbajar by bike [WB 74BD 1189] to play football and on our way near Vega Circle which comes under Bhaktinagar P.S., a car was parked and suddenly the car [number not noted] door opened and our bike was hit and it got disbalanced and we fell down. My friend Albart Tirkey was crushed by an upcoming vehicle, truck [SK04 D1364]. I took Albart Tirkey to the hospital with the help of some locals and on the way, he passed away. The accident took place near Vega Circle in front of Mahindra showroom.

I request you to please take necessary strict action against both of the two above vehicles.
