1) That in the year 2002, I got married with my
husband above named and a baby boy was
born in the year 2004, now he is aged about
17 years.

2) That after the birth of my child, my husband
used to torture me physically and mentally
and he is also a drinker, due to paucity
of fund I have to work in various jobs
such as daily labour etc.

3) That from then on my husband and my
in-laws due to suspicious mind used to
doubt me and on irregular occasion they
used to torture me in various ways and
outcome of the said torture physically or

mentally, I had to leave my Matrimonial home frequently.

4) That from the year 2018, I used to work under my employer namely, Biswanjit Saha and I was engaged as a Commission agent of Setel nut Cutting and I also used to engage 3/4 women in the cutting process and after completion, I used to collect my Commission from my employer after paying the wages.

5) That now my husband and my in-laws for the last 7 to 10 days has tormented me physically and mentally as I couldn't resist the said torture, I left my matrimonial home and staying at my Maternal home for my safety but my husband and my in-laws are threatening me and I am in fear.

It is also to be noted that my life is in danger as they are threatening me to go back at my Maternal home but I don't want to return to my Maternal home due to my life threat.

So, Sir I request you to take necessary steps against my husband and in-laws as per law.
