Accordingly, I along with C/374 Debraj Biswas CVF/ 619 Dharmendra Roy, CVF/014 Labanyamoy Barman headed towards Geetal Para to work out the information. At 16.05 hrs we reached at the spot, and after being identified by the source I along with force held raid at the house of Ram Dular Sahani and recovered the above noted seized articles. On demand he could not produce any valid license/documents in support of said liquor. During interrogation he admitted his guilt before us and stated that he has been selling the same to local people since long for his wrongful gain.
