Sir,

In, producing herewith the arrested accused person namely Ram Dular Sahani s/o Rameshwar Sahani c/o Nathni Sahani of Geetal Para, Buddha Mandir Road, Near Kuti Mill, PS Bhaktinagar, Dist. Darjeeling P/A, Ganganagar, Ward No. 05, PS Siliguri, Dist. Darjeeling arrested U/S 41Cr.P.C along with following seized articles:

- 1] Twenty two (22) Bottles of 60 UP HIMALAYAN GOLD COUNTRY SPIRIT each bottle containing 600 ml.
- 2] Twenty Two (22) Bottles of GALAXY BOSS 60 COUNTRY SPIRIT each bottle containing 600 ml.

I, PSI Sailesh Subba of Bhaktinagar PS/SPC do hereby lodge a written complaint against the arrested accused person namely Ram Dular Sahani s/o Rameshwar Sahani c/o Nathni Sahani of Geetal Para, Buddha Mandir Road, Near Kuti Mill, PS Bhaktinagar, Dist. Darjeeling P/A, Ganganagar, Ward No. 05, PS Siliguri, Dist. Darjeeling to the effect that on 11.09.2021 at around 15.35 Hrs received secret source information that one Ram Dular Sahani has possessed huge amount of illegal liquor at his house at Geetal Para, Near Kuti mill, under Bhaktinagar PS for selling the same to local people. Accordingly, I along with C/374 Debraj Biswas CVF/ 619 Dharmendra Roy, CVF/014 Labanyamoy Barman headed towards Geetal Para to work out the information. At 16.05 hrs we reached at the spot, and after being identified by the source I along with force held raid at the house of Ram Dular Sahani and recovered the above noted seized articles. On demand he could not produce any valid license/documents in support of said liquor. During interrogation he admitted his guilt before us and stated that he has been selling the same to local people since long for his wrongful gain. I then prepared seizure list of the above noted articles in presence of witnesses namely Avijit Das s/o Radhika Prasad Das of and Dinesh Kr Dubey s/o Birendra Dubey undersigned of seizure list. The seizure was made between 16.25 hrs to 16.50 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I, therefore request you to register a specific case against the accused person namely Ram Dular Sahani s/o Rameshwar Sahani c/o Nathni Sahani of Geetal Para, Buddha Mandir Road, Near Kuti Mill, PS Bhaktinagar, Dist. Darjeeling P/A, Ganganagar, Ward No. 05, PS Siliguri, Dist. Darjeeling under proper section of law.
