In producing herewith (03) three arrested accused persons namely (1) Enamul Haque-31yrs s/o Lt Motibul Haque of Vill Mirpara, PS Chopra Dist Uttar Dinajpur (2) Rohit Roy-24yrs s/o Binod Roy of Netajinagar Near Maszid, PS Bhaktinagar Dist Jalpaiguri and (3) Md Sharuk-20yrs s/o Md Safdar of Asrafnagar Near Maszid ward No-40, PS Bhaktinagar Dist Jalpaiguri arrested on 12.09.21 u/s-41 Cr.P.C along with following seized articles viz: -

 One iron rod measuring about 27 inch (approx) from the possession of accused Enamul Haque which was kept on his right hand.

One iron made DAW fitted with wooden butt (Sharp cutting weapon) approx 13 inch from the possession of accused Rohit Roy which was kept on his waist..

 One Iron made Knife measuring about 12 inch (approx) from the possession of accused Md Sharuk which was kept on his right waist.

I, SI- Srimanta Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 11.09.21 at night about 23.45 hrs received a sources information that 10/12 youths have assembled at Gandhi Maidan, Prakashnagar under Bhaktinagar PS for making preparation to commit dacoity in a house at Bhaktinagar PS area. The fact was diarized in G.D vide Bhaktinagar PS GDE No-658 dated 11.09.21 Subsequently after sharing the information with my superiors and as per their direction, at 23.50 hrs myself along with ASI Dipak Karmakar, C/374 Debraj Biswas, CVF/614 Sumit Kumar Roy, CVF/935 Bipliab Roy, CVF/619 Dharmendra Roy, CVF/014 Labannomoy Barman along with kits left for the place to work out the information. Inform night mobile van officer SI Kamal Kumar Sarkar with a request to remain present there. This refers to Bhaktinagar PS G.D.E No - 659 dated 11.09.21 & MCC no-. 780/21 dated 11.09.21. We reached Gandhi Maidan, Prakashnagar, under Bhaktinagar PS at 23.58 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 03 (three) accused persons along with seized articles as mentioned above. However, the other six persons managed to flee away from the spot taking the advantage of darkriess. On interrogation the accused persons admitted that they had assembled there to commit dacoit / in a house at Bhaktinagar PS area. They also stated that another six others fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list and labeled duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made on 12.09.21 in between 00.40 hrs to 01.45 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Enamul Haque-31yrs s/o Lt Motibul Haque of Vill Mirpara, PS Chopra Dist Uttar Dinajpur (2) Rohit Roy-24yrs s/o Binod Roy of Netajinagar Near Maszid, PS Bhaktinagar Dist Jalpaiguri and (3) Md Sharuk-20yrs s/o Md Safdar of Asrafnagar Near Maszid ward No-40, PS Bhaktinagar Dist Jalpaiguri and six others and arrange for its investigation.
